# AMENDMENT NO. 1 TO THE AGREEMENT FOR SERVICES BETWEEN THE CITY OF SANTA CLARA, CALIFORNIA, AND CALIFORNIA SPORTS CENTER

#### PREAMBLE

This agreement ("Amendment No. 1") is entered into between the City of Santa Clara, California, a chartered California municipal corporation (City) and California Sports Center, a California Corporation (Contractor). City and Contractor may be referred to individually as a "Party" or collectively as the "Parties" or the "Parties to this Agreement."

# **RECITALS**

- A. The Parties previously entered into an agreement entitled "California Sports Center" dated September 1, 2018, (the "Original Agreement") for the purpose of having Contractor provide Recreational Instruction; and
- B. The Parties now wish to amend the Original Agreement to terminate on February 28, 2019.

The Parties agree as follows:

## AGREEMENT TERMS AND CONDITIONS

#### 1. AMENDMENT TERMS AND CONDITIONS

- A. That paragraph number 1 of Section 2 of the Original Agreement, entitled TERM OF AGREEMENT shall read:
  - Unless otherwise set forth in this Agreement or unless this paragraph is subsequently modified by a written amendment to this Agreement, the term of this Agreement shall begin on September 1, 2018 and terminate on February 28, 2019.
- B. That the courses and classes described in Exhibit A of the Original Agreement as Amended shall be performed by the Contractor in part on dates between September 1, 2018 and February 28, 2019, according to a schedule published in City's Parks & Recreation Activity Guide(s).

### 2. TERMS

All other terms of the Original Agreement which are not in conflict with the provisions of this Amendment No. 1 shall remain unchanged in full force and effect. In case of a conflict in the terms of the Original Agreement and this Amendment No. 1, the provisions of this Amendment No. 1 shall control.

## 3. COUNTERPARTS

This Agreement may be executed in counterparts, each of which shall be deemed to be an original, but both of which shall constitute one and the same instrument.

The Parties acknowledge and accept the terms and conditions of this Amendment No. 1 as evidenced by the following signatures of their duly authorized representatives.
