

RESOLUTION NO. 22-9091

**A RESOLUTION OF THE CITY OF SANTA CLARA, CALIFORNIA
MODIFYING PARKING REGULATIONS ON BASSETT STREET
BETWEEN CHESTNUT STREET AND GEORGE STREET**

BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

WHEREAS, the City of Santa Clara Bicycle Plan Update 2018 was approved and adopted by the Council on September 24, 2019 as set forth in Council Resolution No. 19-8761;

WHEREAS, the installation of Class II Bicycle Lanes on Bassett Street was a recommendation included within the adopted Bicycle Plan Update 2018;

WHEREAS, the City has established certain parking regulations on Bassett Street between Chestnut Street and George Street;

WHEREAS, the City has determined that a modification to the existing parking regulations on Bassett Street between Chestnut and George Street is necessary to accommodate the proposed Class II Bikeway based on the parking analysis findings and community input as further described in Report to Council (RTC) No. 22-254 which is incorporated herein by this reference; and

WHEREAS, the City intends to establish new parking regulations on Bassett Street between Chestnut Street and George Street in order to accommodate the installation of Class II Bicycle Lanes based on the findings set forth in RTC No. 22-254.

NOW THEREFORE, BE IT FURTHER RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

1. That there is hereby established a "No Stopping Anytime" zone along the east side of Bassett Street between Chestnut Street and George Street, except as provided in Section 2 below.
2. Notwithstanding and subject to Section 1. of this Resolution, on-street parking shall remain along the east side of Bassett Street from the south curb of Norman Avenue to a point 320 feet south of the south curb of Norman Avenue.

3. That the City Manager and/or his or her designee, is authorized to modify parking regulations on Bassett Street between Chestnut Street and George Street as needed to accommodate the installation of Class II Bicycle Lanes.

4. Effective date. This resolution shall become effective immediately upon the award of a contract to install and construct Class II Bicycle Lanes on Bassett Street between Chestnut Street and George Street.
