A RESOLUTION OF THE CITY OF SANTA CLARA, CALIFORNIA MODIFYING PARKING REGULATIONS ON DE LA CRUZ BOULEVARD/COLEMAN AVENUE BETWEEN CENTRAL EXPRESSWAY AND BROKAW ROAD

**WHEREAS**, the City of Santa Clara Bicycle Plan Update 2018 was approved and adopted by the Council on September 24, 2019 under Resolution No. 19-8761;

WHEREAS, Class IV Protected Bicycle Lanes on De La Cruz Boulevard between Central Expressway and Reed Street was a recommendation within the adopted Bicycle Plan Update 2018;

**WHEREAS**, Class II Bicycle Lanes on Coleman Avenue between Reed Street and Brokaw Road was a recommendation within the adopted Bicycle Plan Update 2018;

WHEREAS, De La Cruz Boulevard is also known as Coleman Avenue south of Reed Street;
WHEREAS, the City established certain parking regulations on De La Cruz Boulevard/Coleman
Avenue between Central Expressway and Brokaw Road;

**WHEREAS**, Public Works staff determined that a modification to the existing parking regulations is necessary to accommodate the proposed Class IV Protected Bicycle Lanes and maintain six travel lanes between Central Expressway and Brokaw Road; and,

WHEREAS, the City intends to establish new parking regulations on De La Cruz

Boulevard/Coleman Avenue between Central Expressway and Brokaw Road based on City Public

Works staff findings.

## NOW THEREFORE, BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

- 1. The City Manager, or designee, is authorized to establish a "No Stopping Anytime" zone along the westside side of De La Cruz Boulevard from Central Expressway to Reed Street as needed to implement Class IV Protected Bicycle Lanes.
- 2. <u>Effective date</u>. This resolution shall become effective immediately.
