AMENDMENT NO. 3 TO THE AGREEMENT FOR SERVICES BETWEEN THE CITY OF SANTA CLARA, CALIFORNIA, AND HOUSEKEYS INC.

PREAMBLE

This agreement ("Amendment No. 3") is entered into between the City of Santa Clara, California, a chartered California municipal corporation (City) and Housekeys Inc., a California corporation, (Contractor). City and Contractor may be referred to individually as a "Party" or collectively as the "Parties" or the "Parties to this Agreement."

RECITALS

- A. The Parties previously entered into an agreement entitled "Agreement for Services between the City of Santa Clara, California and Housekeys Inc., dated January 9, 2020 (Agreement);
- B. The Agreement was previously amended by Amendment No. 1, dated August 24, 2021, Amendment No. 2, dated July 27, 2021, and is again amended by this Amendment No. 3. The Agreement and all previous amendments are collectively referred to herein as the "Agreement as Amended"; and
- C. The Parties entered into the Agreement as Amended for the purpose of having Contractor provide administration services for the City's Affordable Rental Program, and the Parties now wish to amend the Agreement as Amended to extend the term of the Agreement for an additional two years through June 30, 2024.

NOW, THEREFORE, the Parties agree as follows:

AMENDMENT TERMS AND CONDITIONS

- 1. Section 2 of the Agreement as Amended, entitled "Term of Agreement" is hereby amended to read as follows:
 - Unless otherwise set forth in this Agreement or unless this paragraph is subsequently modified by a written amendment to this agreement, the term of this Agreement shall begin on July 1, 2018 and terminate on June 30, 2024.
- 2. Revised Exhibit B of the Agreement as Amended, entitled "Fee Schedule" is hereby amended to read as shown in Second Revised Exhibit B, attached herein.

Amendment No. 3 to Agreement/Housekeys Inc. Rev. 10/25/19

 Except as set forth herein, all other terms and conditions of the Agreement as Amended shall remain in full force and effect. In case of a conflict in the terms of the Agreement as Amended and this Amendment No. 3, the provisions of this Amendment No. 3 shall control.
