- 1. That the City Council hereby finds that the above Recitals are true and correct and by this reference makes them a part hereof.
- 2. That the FY 2022/23 Municipal Fee Schedule last adopted on April 19, 2022, is hereby amended to update the existing room rental fees under the Library Department, under exemption 4 ("A charge imposed for entrance to or use of local government property, or the purchase, rental, or lease of local government property"), as shown on the attached Municipal Fee Schedule Change – Library Fees document.
