

RESOLUTION NO. 18-8639

**A RESOLUTION OF THE CITY OF SANTA CLARA, CALIFORNIA
DELEGATING AUTHORITY TO THE CITY MANAGER TO
APPROVE SPECIAL PERMITS IN CONNECTION WITH THE
COLLEGE FOOTBALL PLAYOFF NATIONAL CHAMPIONSHIP**

BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

WHEREAS, Santa Clara City Code (SCCC) Chapter 18.60 authorizes the City Council to approve Special Permits for temporary uses and structures;

WHEREAS, on January 7, 2019, the College Football Playoff National Championship is scheduled to take place at Levi's Stadium;

WHEREAS, the City anticipates that it will receive Special Permit applications for temporary uses on private property related to the College Football Playoff event;

WHEREAS, City Charter Section 802(h) authorizes the City Council to delegate its authority to the City Manager; and,

WHEREAS, in order to facilitate the granting of Special Permits in connection with the College Football Playoff National Championship, the City Council would like to delegate its authority to issue Special Permits under SCCC Chapter 18.60 to the City Manager or her designee.

NOW THEREFORE, BE IT FURTHER RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

1. That the City Manager, or her designee, is authorized to approve and execute Special Permits for temporary uses and structures that would otherwise require City Council approval under SCCC Chapter 18.60.
2. This delegation of authority shall expire one calendar day following the conclusion of the 2019 College Football Playoff National Championship at Levi's Stadium, which is currently scheduled for January 7, 2019.

3. Effective date. This resolution shall become effective immediately.
