#### **GENERAL BUSINESS**

24-807 Review and Approve the Santa Clara City Library Draft Strategic Plan

**Recommendation:** Review and Approve the Santa Clara City Library Draft Strategic Plan.

City Librarian Wong reviewed with the Board updates to the content of the Library Strategic Plan. The Board reviewed the Mission and Vision statements, Goals, Objectives, and examples of Activities to be undertaken to achieve the Goals and Objectives. The Board held discussion and provided suggestions and insights. City Librarian Wong informed the Board that the Library will continue to engage staff in refining the plan, and will provide an update at the next regular meeting of the Board of Library Trustees on September 16, 2024.

# STAFF REPORT

City Librarian Wong informed the Board that Acting Assistant City Manager Michelle Templeton will be departing Santa Clara for a new position as Assistant City Manager in Santa Cruz, and that Assistant City Attorney Elizabeth Klotz has been asked to assume her role. When the decision is finalized as to which member of the City Manager's Office team the Library will report to, the Board will be updated.

Discussion was held on the Facilities Master Plan project, with an update that the consultants will be attending the Santa Clara Art & Wine Festival on September 14-15, 2024. The consultants will have boards to display, to communicate to and collect data from the public at this event. The boards were reviewed with the **Board** and feedback was shared. There was a call for volunteers for the Art & Wine Festival, as well as for Comic Con, scheduled for October 12, 2024 at Central Park Library.

City Librarian Wong thanked Trustee Huynh for attending the 10th Anniversary celebration for Northside Branch Library, and shared an update on the strong attendance at the event.

#### TRUSTEES REPORT

Trustee Huynh shared that he spoke to a Library customer at National Night Out. The customer sought technology assistance at the Tech Center at Central Park Library. They mentioned that staff seemed overworked assisting so many Library customers, and that the Library used to partner with Santa Clara High School to have teens volunteer to help community members with their technology questions. This feedback was shared with staff, who received the suggestion and discussed service and capacity needs.

The meeting was adjourned at 7:33 PM.

# **MEETING DISCLOSURES**

The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision. Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. If a person wishes to challenge the nature of the above section in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Santa Clara, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.

If a member of the public submits a speaker card for any agenda items, their name will appear in the Minutes. If no speaker card is submitted, the Minutes will reflect "Public Speaker."

In accordance with the requirements of Title II of the Americans with Disabilities Act of 1990 ("ADA"), the City of Santa Clara will not discriminate against qualified individuals with disabilities on the basis of disability in its services, programs, or activities, and will ensure that all existing facilities will be made accessible to the maximum extent feasible.
