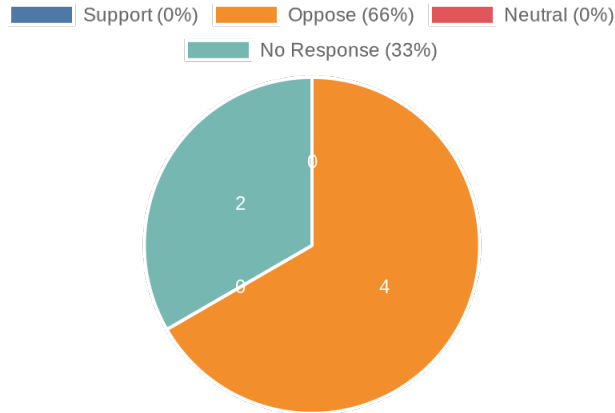

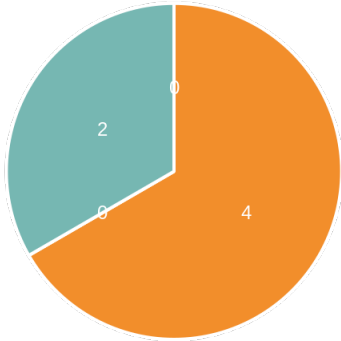

Critical Recommendation: Justification and Contractual Clause

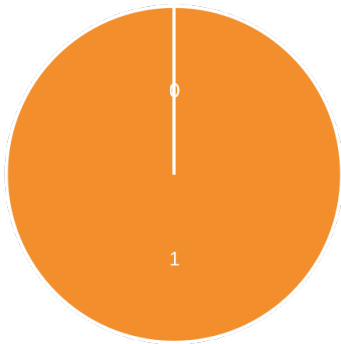

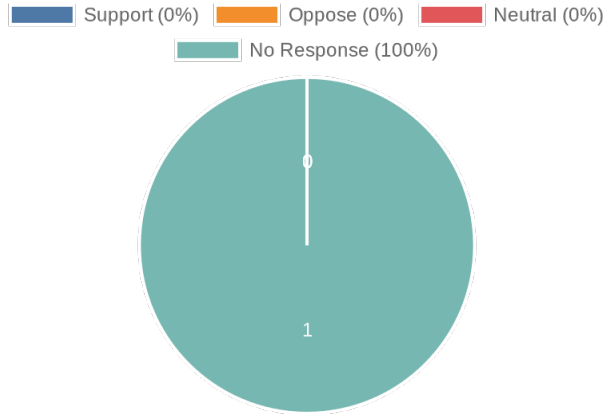
