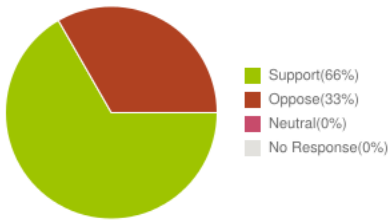

This includes sections D3-D6 for restoring natural creek functions while mitigating flooding.
