Re: Support for the City of Santa Clara's Fiscal Year 2024 Federal Appropriations Request

Dear Senator Feinstein, Senator Padilla, and Congressman Khanna:

I am writing to express my strong support for the City of Santa Clara's three community project requests for which we are seeking funding: Public Safety Communications Infrastructure Funding, Great America Parkway Congestion Relief and Multimodal Improvement Project, and Harrison St. and North Winchester Drive Storm Drain Flood Protection Project.

The City of Santa Clara is requesting funding for these projects as they will enhance regional public safety response, improve traffic congestion at a key regional intersection, and provide flood protection benefits to a Santa Clara neighborhood.

Public Safety Communications Infrastructure Funding - The City is a member of a countywide organization dedicated to facilitating interoperable voice and data communications known as Silicon Valley Regional Interoperability Authority (SVRIA). This system operates on a P25 digital radio system that allows public safety entities throughout Santa Clara County interoperability in situations where a multi-jurisdictional response is necessary, such as severe storm, flooding, fires, earthquake, active shooter, mutual aid situations, and domestic terrorism. Critical incidents that have required the use of these radios include the Gilroy Garlic Festival and Valley Transportation Authority shootings. The City's Police and Fire Departments also respond to the daily needs of the community, and routinely prepare to respond to critical incidents in the City, region, and throughout the state. In 2022, the Communications Center received 161,398 emergency and non-emergency calls for service. Many of the City's portable and mobile radios are nearing the end of their serviceable life and are in need of replacement. As technology changes and new radio features are introduced, new radios are important to the City's communication infrastructure as well as the regional success of SVRIA and the protection of the communities we serve.

- Great America Parkway Congestion Relief and Multimodal Improvement Project Great America Parkway/Mission College Blvd is a regionally significant intersection that connects the US-101 and State Route 237 freeways to key destinations in the heart of Silicon Valley, including: Levi's Stadium, Santa Clara Convention Center, Great America Amusement Park, Mission College, as well as the headquarters of companies having a combined stock market capitalization of over \$500 billion such as Intel, Advanced Micro Devices, Applied Materials, Chegg, and Marvell Technology. The project will improve roadways at the intersection through the installation of buffered bicycle lanes, new sidewalks, additional travel lanes, traffic signals modifications, and pavement improvements with the goal of reducing traffic congestion for 64,000 vehicles that currently use the intersection each day. The project was approved by the Santa Clara City Council to reduce traffic congestion anticipated by future development of over 20,000 housing units, 12 million square feet of office, and 2 million square feet of retail in the area. Over the next 20 years, the project is anticipated to save 22 million hours of time, 10,300 tons of greenhouse gas emissions, and 2.8 million gallons of fuel. These benefits achieve goals within the City's General Plan, the Valley Transportation Authority Congestion Management Program, and the Metropolitan Transportation Commission Regional Transportation Plan/Sustainable Communities Strategy.
- Harrison St. and North Winchester Drive Storm Drain Flood Protection Project The Harrison St. neighborhood east of San Tomas Aquino Creek and North Winchester Drive area is bounded by residential homes and commercial businesses. The affected areas are constantly experiencing flooding during annual storm events and the project is one of the highest priority flood protection storm drain system improvement projects identified in the City's Storm Drain Master Plan. The project will meet current flood protection requirements by upsizing an existing storm drain system at Harrison St. in which approximately 3,200 linear feet of storm drain pipeline ranging in diameters between 12-inch and 21-inch will be improved. For the North Winchester Drive area, proposed work includes installation of approximately 500 feet of 12-inch storm drain pipelines and various catch basins and manholes. Hundreds of residents and businesses will benefit and receive flood protection from the project.

These projects are critical for Santa Clara and will provide long term benefits to residents, businesses, and visitors in the greater Silicon Valley region. For these reasons, I ask that you give positive consideration to the City's requests for funding.

On behalf of the City of Santa Clara, I want to express my enthusiasm about continuing to build a strong relationship between the City and your office.

As the State Legislature continues to evaluate funding priorities, as part of the FY 2023-24 Budget process, I am respectfully presenting a list of priority projects that the City would like to partner with you on.

Through discussions with City officials, the City has identified four priority projects that we believe would be worthy recipients of state funding given their significant local and regional impacts. As such, we seek to partner with you to secure funding in the 2023 State Budget. The funding requests have been placed in order of priority.

1. Regional Public Safety Interoperable Radio Communications Amount Requested: \$2,500,000

Project Description: The City is a member of a countywide organization dedicated to facilitating interoperable voice and data communications known as Silicon Valley Regional Interoperability Authority (SVRIA). This system operates on a P25 digital radio system that allows public safety entities throughout Santa Clara County interoperability in situations where a multi-jurisdictional response is necessary, such as severe storm, flooding, fires, earthquake, active shooter, mutual aid situations, and domestic terrorism. Critical incidents that have required the use of these radios include the Gilroy Garlic Festival and Valley Transportation Authority shootings. This two-way radio infrastructure is also critical in managing large-scale events at Levi's Stadium as local, state and federal law enforcement is necessary to carry out each major event at this venue.

2. Cupertino-Santa Clara On-Demand Micro-Transit Shuttle Project Amount Requested: \$2,500,000

Project Description: The City of Santa Clara is partnering with the City of Cupertino to implement an on-demand micro-transit shuttle project to serve those who live and work in Cupertino and Santa Clara. With support from a California State Transportation Agency State Transit and Intercity Rail Capital Program (TIRCP) grant, the goal is to continue Cupertino's existing On-Demand Micro-Transit Shuttle program and expand service into Santa Clara with a fleet of zero-emissions vehicles. Service is being designed to focus on offering improved and affordable connections between local Caltrain, Amtrak, VTA stations to job centers and other key destinations in Cupertino and Santa Clara while providing increased transit access for disadvantaged communities, high poverty zones, and senior populations.

3. Great America Parkway Congestion Relief and Multimodal Improvements Project Amount Requested: \$2,500,000

Project Description: This project will relieve congestion and improve the City's multimodal environment by constructing bicycle facilities and travel lane and traffic signal improvements at a major intersection in the North Santa Clara area. The project is located at the intersection of Great America Parkway and Mission College Boulevard and connects the US-101 and State Route 237 freeways to key destinations in the heart of Silicon Valley, including Levi's Stadium (1.1 million visitors in 2019), the Santa Clara Convention Center (318,000 visitors in 2019), Great America Amusement Park (1.5 million visitors in 2019), Mission Community College (serves over 10,000 students), Mercado Shopping Center (over 200,000 square feet of retail), as well as the headquarters of major companies like Intel, Advanced Micro Devices, Applied Materials, Marvell Technology, and Chegg. In addition to serving these destinations, the City is working on Long Range Plans to add over 20,000 housing units, 12 million square feet of office space, and 2 million square feet of retail in the North Santa Clara area that is served by this intersection. This project will improve safety and increase mobility for all users of this major transportation corridor in Santa Clara.

4. SC Overnight Care Locations Amount Requested: \$1,800,000

Project Description: Unprecedented weather events of the past year have amplified the need for the City to address basic needs of people living outside for shelter, health, and hygiene. While the City opens warming/cooling centers in City facilities during normal business hours, there is a need to extend hours to include overnight hours. Modeled after the OWL (Overnight Warming Location) Program in San Jose, this project seeks to establish up to two sites in Santa Clara where the unhoused will have a safe place to gain respite from inclement weather conditions, address immediate needs for food and access support services. The City recently drafted a Homelessness Response Plan which has identified this gap in service as a critical need. While the City is piloting a mobile shower and laundry service and works collaboratively with local non-profits to provide support services, there is currently no overnight shelter or emergency interim housing in Santa Clara. Consequently, the basic needs, health, and welfare of unhoused individuals in Santa Clara are going unmet. This project would fund the initial investment to launch pop-up emergency overnight facilities, fund a dedicated street and encampment outreach team and staff overnight care locations for a two-year period. Funding would also be used to explore partnerships with

Valley Water, the County, Caltrans, railroads, businesses, nonprofits, faith-based and volunteer organizations to leverage funding, facilities, expertise and staffing to manage the impacts of encampments and support clean-up activities near encampments, parks, creeks and other locations in the City in an effort to create a more comprehensive homelessness response.

I am optimistic that these project requests align with state goals and would be a worthy investment of state funds. Thank you for your consideration.

Dear California Legislative Budget Leadership,

On behalf of the City of Santa Clara, I write in support of a request for a one-time budget allocation of \$5 million to fund the recently-established Employee Ownership Hub within the Governor's Office of Business and Economic Development which was created in 2022 through the passage of SB 1407, the California Employee Ownership Act.

The Employee Ownership Hub will help establish the infrastructure necessary to increase employee ownership throughout California. As the Legislature prepares for a potential budget shortfall, it is vital that we remain steadfast in the commitment to bolster local economies and protect jobs. This \$5 million investment will not only help develop more wealth building opportunities, but will create more resiliency in the economy. Research shows that worker-owned businesses are less likely to lay off workers, and more prepared to pivot business strategy, during downturns. Employee-owned firms were four times more likely to retain jobs at the height of the COVID-19 pandemic. This trend of business resiliency has held true over multiple past recessions. With wide-reaching worker ownership, more businesses would be able to weather the storm of economic stagnation. Investment in employee ownership can serve as a key element of California's strategy for economic resilience, and a safety net for our state's small businesses.

Employee-owned businesses, commonly formed as worker cooperatives (co-ops) or Employee Stock Ownership Plans (ESOPs), provide proven benefits including stronger business performance, and quality jobs and wealth building opportunities for employees. Expanding employee ownership benefits businesses, workers, and local economies.

There is no better time for California to embrace employee ownership to preserve small businesses. According to national surveys, 79% of business owners want to retire within 10 years, 60% in less than 5 years, and 33% in less than 3 years. Without intervention, many of these businesses will close. Only 15% of businesses successfully transition to the next generation in the family. Most business owners who attempt to sell are not able to, with only 20% of commercial listings actually selling. Rather than closing for good or selling to large, out-of-state buyers, small business owners can find willing buyers in the people who work alongside them every day & know their businesses best: their Re: Request for \$5 million to fund the recently-established Employee Ownership Hub within the Governor's Office of Business and Economic Development.

workers. Doing so will anchor essential production and services in communities, protect livelihoods, avert layoffs, and save the State money.

Investment in employee ownership can also serve as a component of California's strategy to close the racial wealth gap. The average Black and Latino household in the United States holds only fifteen to twenty percent of the wealth of the average white household. Alarmingly, this racial wealth gap has been widening over the last decades rather than shrinking. California needs to take bold action to address the racial wealth gap, and investment in employee ownership can be part of the plan. Research shows that employee ownership narrows the racial wealth gap, with Black and Latino workers at employee-owned firms building on average tens of thousands of dollars more in wealth than the average U.S. worker.

Building on provisions in the 2022 Budget, and recent recommendations from state entities such as The Little Hoover Commission's recent report, First Steps toward Recovery: Saving Small Businesses, we respectfully submit the following for consideration in the 2023-24 Budget:

Employee Ownership Hub – \$5M to fund for three years the newly created Employee Ownership Hub within the Governor's Office of Business and Economic Development. The Hub will provide support and align the work of various state agencies in support of broad-based employee ownership.

Despite its long-proven benefits, awareness of employee ownership remains low. Funding the Employee Ownership Hub is critical to sharing information on and reducing barriers to employee ownership, thus maximizing benefits for California workers, businesses, and local economies.

Workers becoming owners creates opportunities for wealth-building, community stability, as well as union partnership, and helps California create a more inclusive, equitable and stable economy fit for the 21st century. We appreciate your consideration of these evidence-based recommendations for this year's proposed budget.

Dear Assemblymember Kalra:

On behalf of the City of Santa Clara, I would like to express our strong support for AB 1469, which makes changes to the Santa Clara Valley Water District Act to allow the agency to do more to assist unsheltered people living along creeks and streams, including providing housing or improved outcomes for unsheltered individuals.

Santa Clara County is currently experiencing unprecedented increases in the number of unhoused people taking refuge along waterways that run through neighborhoods, parks, and open spaces, as well as through commercial districts and industrial areas. As the regional agency responsible for water supply, flood protection, and the environmental stewardship of creeks and streams, the Santa Clara Valley Water District (Valley Water) owns hundreds of miles of property along waterways as well as other public lands. These locations are a preferred refuge for unsheltered people because of their proximity to surface water and the sheltering effects of riparian vegetation, canyons, and creek banks. Valley Water estimated in February 2023 that more than 2,000 unsheltered people were taking refuge on the agency's properties and easements.

AB 1469 (Kalra) would provide Valley Water with the statutory authorization to use its land and a portion of its general tax revenue to humanely assist unsheltered people living along waterways to provide outreach, transitional housing, or other supportive services through contracts with cities, the County, or non-governmental organizations. The goal is to bring more resources to the table to facilitate solutions to serious environmental and operational impacts of large numbers of unsheltered people living along creeks and streams.

The City of Santa Clara strongly supports AB 1469 because it will enable Valley Water to do more to assist unsheltered people taking refuge along waterways, provide more resources to support the efforts of cities, the County, and non-governmental organizations to address the homelessness crisis in our region, and will give Valley Water the tools it needs to improve water quality and protect sensitive, threatened, and endangered species. We urge the Legislature and the Governor to enact this important legislation.

Santa Clara County is currently experiencing unprecedented increases in the number of unhoused people taking refuge along waterways that run through neighborhoods, parks, and open spaces, as well as through commercial districts and industrial areas. As the regional agency responsible for water supply, flood protection, and the environmental stewardship of creeks and streams, the Santa Clara Valley Water District (Valley Water) owns hundreds of miles of property along waterways as well as other public lands. These locations are a preferred refuge for unsheltered people because of their proximity to surface water and the sheltering effects of riparian vegetation, canyons, and creek banks. Valley Water estimated in February 2023 that more than 2,000 unsheltered people were taking refuge on the agency's properties and easements.

AB 1469 (Kalra) would provide Valley Water with the statutory authorization to use its land and a portion of its general tax revenue to humanely assist unsheltered people living along waterways to provide outreach, transitional housing, or other supportive services through contracts with cities, the County, or non-governmental organizations. The goal is to bring more resources to the table to facilitate solutions to serious environmental and operational impacts of large numbers of unsheltered people living along creeks and streams.

The City of Santa Clara strongly supports AB 1469 because it will enable Valley Water to do more to assist unsheltered people taking refuge along waterways, provide more resources to support the efforts of cities, the County, and non-governmental organizations to address the homelessness crisis in our region, and will give Valley Water the tools it needs to improve water quality and protect sensitive, threatened, and endangered species. We urge the Legislature and the Governor to enact this important legislation.

I am writing to express the City of Santa Clara's support for the Santa Clara Valley Water District's (Valley Water) application for a \$350,000 Adaptation Planning Grant to conduct a planning study on San Tomas Aquino Creek. The planning study will be conducted along a segment of San Tomas Aquino Creek in the City of Santa Clara, between Highway 101 to Highway 237. The purpose of this study is to seek sustainable solutions for flood risk reduction.

As part of Valley Water's Safe, Clean Water and Natural Flood Protection Program, Project F8 ("Sustainable Creek Infrastructure for Continued Public Safety") evaluated a variety of creeks and prioritized the creeks based on factors, including flood risk, deteriorating infrastructure, and operations and maintenance. It was determined that a project for San Tomas Aquino Creek should be undertaken as priority number one, with emphasis on specific reaches from the San Francisco Bay to the Wildcat Creek confluence. As the Mayor representing the city that would benefit from additional flood risk reduction measures, I offer my full support for a planning study for this project.

Currently, Valley Water has undertaken an aggressive and expensive sediment and vegetation removal program downstream of Highway 237 to maintain conveyance upstream of Highway 237 to its level of service. The proposed planning study will research and develop a more holistic approach to address concerns throughout the channel to reduce flood risk and meet Federal Emergency Management Agency (FEMA) standards, stabilize the channel to minimize maintenance costs, consider the effects of sea level rise, and rehabilitate aging infrastructure in the most cost-effective manner, and will ultimately benefit Santa Clara residents and the greater San Francisco Bay Area community.

Santa Clara has worked with Valley Water (the county's primary water resources agency) for decades to develop recycled water to offset use of the potable water supply. The City of Santa Clara has supported the implementation and operation of the Silicon Valley Advanced Water Purification Center and the South Bay Water Recycling system for the expansion of nonpotable supply, and actively participated in the Countywide Water Reuse Master Plan (CoRe Plan) effort completed by Valley Water in 2021.

This grant would provide an opportunity to evaluate the feasibility of further expanding reuse for our Silicon Valley communities and improve reliability through a drought-resilient supply. Current state regulations enable communities to use recycled water for drinking via a reservoir or aquifer, and in 2023, the State Water Board will establish direct potable reuse regulations that will allow suppliers to distribute recycled water without first putting the water into a reservoir or aquifer.

Water reuse planning would begin with the development of a Collaborative Agreement presenting a scope of water reuse projects and/or capital improvements that would support each agency's goals to improve water supply reliability. The Agreement would describe an approach to share costs for joint recycled water projects and capital improvements; assign responsibility to operate and maintain facilities; recommend to our respective governing bodies how we can improve our current governance structure related to their joint recycled water
