2. 23-849 Initiate the Formal Community Input Process on the Proposed Schematic Design of a New Public Neighborhood Park at 2200 Calle De Luna (Holland)

Recommendation: Initiate community outreach and provide input on the initial Schematic Design for a new Neighborhood Park to be located at 2200 Calle De Luna.

> The Commission appreciated how the natural elements blended with surrounding environment in the schematic design. The Commission had positive comments about the quantity of trees and wanted to ensure there would be sufficient tree shade when the park is completed, which the Consultant confirmed. The Commission further commented on the need to have the enclosed area of the playground designed with shrubs and trees so that fencing would be unobtrusive and not detract from the nature based aesthetics of the setting.

Acting Director of Parks & Recreation Seale reported that the Westwood Oaks Park Playground Rehabilitation Project is starting in late September; Fairway Glen Park Restroom Project field work will be starting in late September or October; the Magical Bridge All-Inclusive Playground is on schedule; International Swim Center (ISC) consultant's Agreement to evaluate ISC has been executed. The Everett N. "Eddie" Souza Park building has been open for about a month. Please check the Park Projects page for additional park project updates.

Recreation Manager Castro reported on the expansion of the Senior Center hours, now Monday and Wednesday 7:00 AM - 7:00 PM; Tuesday, Thursday, and Friday 7:00 AM - 3:00 PM; Saturday 8:00 AM - 12 Noon. There is a Concert in the Park this Friday at Central Park, and at Live Oak Park next month. Manager Castro will send an email to Commissioners to advise them of available volunteer opportunities for them during the 41st Annual Art & Wine Festival.

MEETING DISCLOSURES

The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision. Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. If a person wishes to challenge the nature of the above section in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Santa Clara, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.

If a member of the public submits a speaker card for any agenda items, their name will appear in the Minutes. If no speaker card is submitted, the Minutes will reflect "Public Speaker."

In accordance with the requirements of Title II of the Americans with Disabilities Act of 1990 ("ADA"), the City of Santa Clara will not discriminate against qualified individuals with disabilities on the basis of disability in its services, programs, or activities, and will ensure that all existing facilities will be made accessible to the maximum extent feasible.
