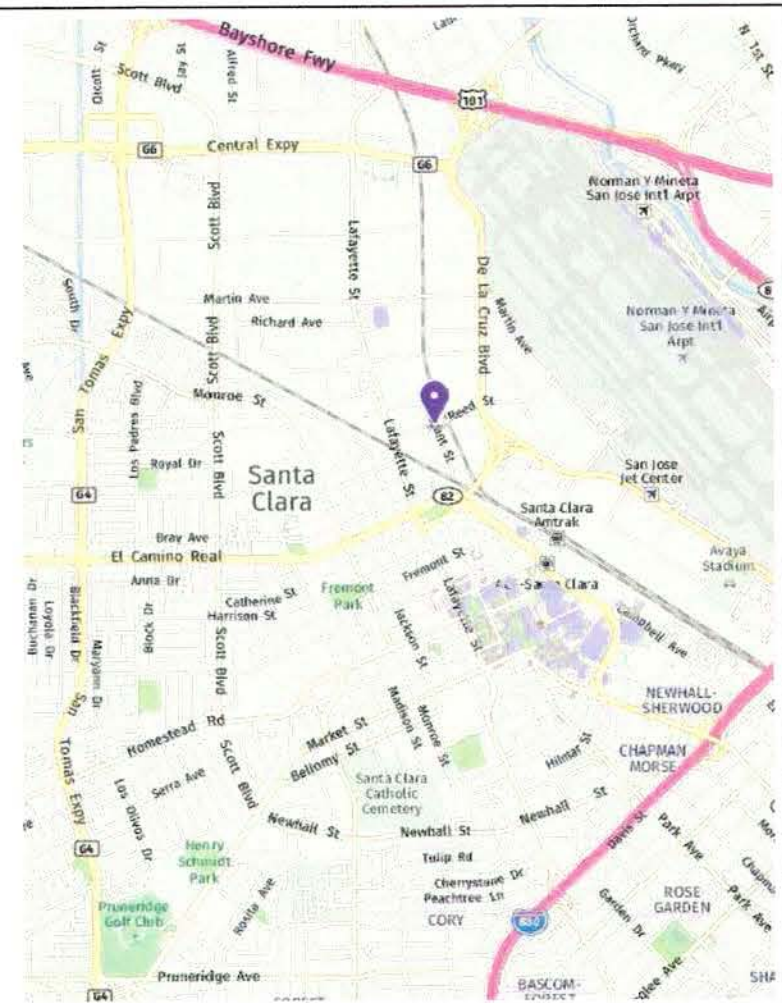
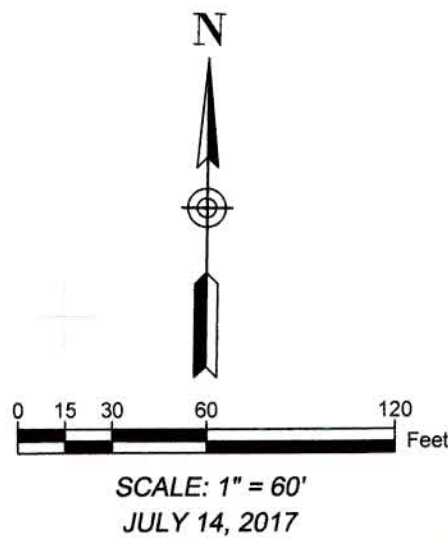


TENTATIVE PARCEL MAP
