Subject: Planning Commission Selection Process

The Planning Commission discussed the Planning Commissioner selection process at their March 13, 2019 meeting and indicated an interest in being able to suggest questions to be asked to Commissioner candidates. Specifically, they suggested that candidates should be asked about their ability to make the necessary time commitment to attend Planning Commission meetings, prepare in advance for those meetings and attend Planning Commissioner conferences and trainings such as those conducted by the League of Cities. The Commission meets approximately 20 times per year (1 or 2 meetings per month) with meetings held on Wednesday evenings beginning at 6:00 PM and lasting 3-4 hours with 4 or 5 projects on each agenda. Preparation time can require several hours for each meeting including time for site visits and reading environmental documents and staff reports.
