In early 1991, I participated in a construction walk through of the Youth Activity Center with Earl Carmichael, Larry Wolfe and Rick Hutchinson. It was my first glance of their vision for a premier youth sports facility which would open that summer.

Stephanie Dungan, Kristin Armbruster and myself were hired to open the facility and coordinate the initial programming for the youth in our community. In the early years, unique classes, youth sports leagues, summer camps, after school programming, open gym, and special events were developed through hard work of recreation leaders, independent contractors and community partners.

Over the years, the community benefits have reached so many individuals and families, none of which is measured through enrollment or revenue, like:

- Single mom who would sign her two young boys up for Parents Night Out as her once a month chance to get caught up on laundry and read quietly by herself
- A safe place after school for so many kids who would be latchkey kids otherwise
- A place for the Youth Commission to start in 1995, and grow over the years
- The volunteer hours students have contributed to serve their peers and meet graduation requirements
- The work ethic and leadership skills gained by staff members in their first job

In 1996, Gayle Ichiho (Swish) took over the reigns at the YAC as the Sports Coordinator and never looked back. Swish, Oba, Gohan and their amazing team have taken the center to new heights. They are the most welcoming, creative, innovative and thoughtful role models in the profession. Their programming is well-respected and well-attended, and they have created a fun family atmosphere that has kids, volunteers, interns and staff coming back year after year with their silly camp names, cool costumes, amazing decorations, over the top potlucks and staff trips make the YAC more than just a job.

Like many of the staff, our daughter (Waffles) started as a camper at age 5, served as a volunteer for three summers and COVID disrupted her ability to start working at the center in 2020. The YAC is her happy place, where she can get help with homework, be an athlete, spend time with friends, and be a role model to younger YACsters. It is an extension of our family!

NEVER in a million years did Earl, Larry or Rick imagine this day would come! But, they would be pleased to know their vision for a model youth sports center is continuing as a result of the long-term partnership with school district administrators and the staff at Cabrillo Middle School.
