**CITY OF SANTA CLARA  
SUMMARY OF INVESTMENT PORTFOLIO**

All securities held by the City of Santa Clara as of April 30, 2024 were in compliance with the City's Investment Policy Statement regarding current market strategy and long-term goals and objectives. All securities held are rated A or higher by two nationally recognized rating agencies. There is adequate cash flow and maturity of investments to meet the City's needs for the next six months.

The following table provides the breakdown of the total portfolio among the City, the Sports and Open Space Authority (SOSA), and the Housing Authority (HA) as of April 30, 2024.

On April 30, 2024 the cost value and market value of the City's unrestricted pooled investment portfolio were \$1,134,976,686 and \$1,109,843,860 respectively.

Investment Strategy and Market Update

The market's expectations for the number of rate cuts from the Federal Reserve (Fed) fell during April due to inflation readings coming in above expectations and hawkish Fed commentary. After the May Federal Open Market Committee (FOMC) meeting — during which the Fed left the range for the overnight target rate unchanged at 5.25% to 5.50% — Fed Chair Jerome Powell noted that it is likely going to take longer than previously expected for the Fed to gain greater confidence that inflation is moving sustainably lower towards its 2% target. The market reaction was tempered by the fact that Chair Powell indicated an additional rate hike was unlikely.


The trend of hotter-than-expected inflation readings continued in April. The Consumer Price Index (CPI) exceeded estimates for the third consecutive month as the year-over-year (YoY) change rose to 3.5%, the highest level since September. PCE also rose for the first time in five months, increasing to 2.7%. The YoY change in Core PCE (which excludes volatile food and energy components) was unchanged from the prior month at 2.8%, ending the recent run of 14 consecutive monthly declines.

The April jobs report pointed to the labor market continuing to settle into equilibrium. The nonfarm payrolls report came in below expectations and fell to 175,000 but is still above the level necessary to keep pace with population growth. The unemployment rate also ticked up to 3.9% but has remained below 4% for 27 consecutive months, which is the longest such streak since the 1960s. Yields declined on the news as the market interpreted the data as evidence that the hot labor market may be starting to normalize.


The yields on benchmark 2-, 5-, and 10-year U.S. Treasuries ended the month at 5.04%, 4.72%, and 4.68%, respectively, representing changes of +42, +50, and +48 bps for the month, respectively.

The City's investment strategy for April 2024 was to invest funds not required to meet current obligations, in securities listed in the prevailing Investment Policy Statement, with maturities not to exceed five years from date of purchase. This strategy ensures safety of the City's funds, provides liquidity to meet the City's cash needs, and earns a reasonable portfolio return. PFM Asset Management LLC began actively managing the City's securities portfolio on September 1, 2020.

As of April 30, 2024, 43.52% of the City's portfolio consists of U.S. Treasury Notes, 18.24% consists of California Asset Management Program (CAMP), 16.20% consists of investment grade Corporate Notes, 8.03% consists of Federal Agencies, 5.66% consists of investment grade Asset-Back Securities, 5.12% consists of investment grade Mortgage-Backed Securities, 1.30% consists of Negotiable Certificates of Deposit, 0.97% consists of investment grade Supranational Obligations, 0.52% consists of Local Agency Investment Fund (LAIF), and 0.24% consists of investment grade Municipal Bonds. In addition, City bond proceeds are invested in separate funds and are not included in the calculation of the City's portfolio yield.



The City's securities portfolio is benchmarked against the ICE BAML 1-5 US Treasury Index.


