<u>24-710</u> Discussion and Possible Action on Santa Clara City Library Draft Strategic Plan

Recommendation: Review and discuss project updates on the Santa Clara City Library Draft Strategic Plan.

City Librarian Wong reviewed with the **Board** the work in progress on the Library Strategic Plan. Updates on the revised goals and objectives with sample activities were shared. The **Board** agreed to plan a special meeting of the **Board** on August 19, 2024 from 5:30 PM to 7:30 PM for focused review and discussion of revisions to the Library Strategic Plan.

STAFF REPORT

City Librarian Wong informed the **Board** of the proposed city general obligation bond planned to be on the ballot at the November election. She provided information on the potential impact for the Library, with examples of possible high priority uses and description of relevant parameters of use.

Discussion on community engagement efforts by the **Board** were discussed, with interest from **Trustee Ricossa** in attending the **Parks and Recreation Commission** meetings, **Trustee Tryforos** in attending **Youth Advisory Commission** meetings, and **Chair Evans** having previously expressed interest in attending **Cultural Commission** meetings on behalf of the **Board of Library Trustees.**

The **Board** was updated on recent community concern for the health of an unhoused community member staying in front of the Library, and efforts to assist the individual with information regarding available community resources. Discussion included the recent **Supreme Court** decision regarding the unhoused, current practices in Santa Clara, and updates on the return of the **Park Patrol** and its positive impacts.

Updates were provided on initial efforts in support of the Library Facilities Master Plan, with consultants planning community engagement efforts at the upcoming Art and Wine Festival, Library Comic Con, and possible engagement with the **Board** at an upcoming regular meeting.

City Librarian Wong also informed the Board that the Library was engaged in reviewing its policies and procedures in coordination with the City Attorney's Office.

TRUSTEES REPORT

The new members of the **Board of Library Trustees** were provided information by continuing **Trustees** about how the Trustees Report part of the regular board meeting is often used. Discussion touched on bicycle repair as a service, as well as possible agenda items for upcoming discussion. The September regular meeting agenda items are planned to include a draft of the 2025 **Board of Library Trustees** Meeting Calendar, to include meetings being hosted at all three Library locations. **Trustee Tryforos** mentioned that the **Board** has appreciated when staff provide presentations to update and inform the **Board** on their programs and services, if more could be planned in the future.

The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision. Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. If a person wishes to challenge the nature of the above section in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Santa Clara, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.

If a member of the public submits a speaker card for any agenda items, their name will appear in the Minutes. If no speaker card is submitted, the Minutes will reflect "Public Speaker."
