# **Background**

- August 30, 2022 Council voted to place an item on a future agenda to discuss potential ballot measures to transition the Police Chief and/or City Clerk from elected to appointed positions.
  - This would require a Charter Amendment, approved by voters
- Staff is bringing this item so that the City Council has sufficient time to decide and appoint a Charter Review Commission prior to 2024 election deadlines set by the Santa Clara Registrar of Voters



# **Background**

- Election Options for Items Already Discussed
  - March 5
    - · Can include Police Chief and/or City Clerk Charter Amendment
  - November 5
    - Can include the Police Chief and/or City Clerk Charter Amendment as well as tax measures. Tax measures can only be considered at a regularly scheduled general election, unless an emergency is declared by unanimous vote of the governing body
- **Estimated Election Costs** 
  - March 5 or November 5

# **Size & Appointment Process**

- Recommend odd number of appointments with a size ranging between 7 & 11.
- · Recommend standard eligibility & conflict of interest requirements apply.
- Names of nominees be provided to City Clerk no later than July 7, 2023 for verification of eligibility. Consideration of final appointments to be brought forward at the July 18, 2023 Council meeting.

Option #	Description
1	Application process similar to process used to appoint to Boards & Commissions
2	Mayor & Council each nominate one member, nominees appointed by full Council
3	Another process deemed appropriate by Council (hybrid): 1 nominee each by Mayor & Council with additional members selected through recruitment.



# **Council Direction, Scope of Work**

- Question #1: Does the City Council wish to consider proposed amendments to the City Charter that would change positions of Police Chief and/or City Clerk from elected to appointed positions?
  - If yes, for one or both positions?
  - If yes, does the City Council want to provide direction on who positions should be appointed by, if not elected?
  - If yes, should these items be placed on the March 5 or November 5 ballot?
- Question #2: Does the City Council wish to establish a Charter Review Committee?
  - If yes, does the Council prefer Option 1, 2 or 3 for selection of members?
- Question #3: Should the same eligibility & conflict of interest requirements used for Boards & Commission apply?

### Recommendation

- If the City Council chooses to proceed with a measure(s) to amend the City Charter:
  - Direct staff to proceed with public input process including establishment of CRC to consider a proposed amendment to the City Charter on the March 5, 2024 ballot that would change the positions of Police Chief and/or City Clerk from elected to appointed positions with the scope, size, and method of appointment for the CRC to be defined by the City Council.
