**WHEREAS**, on April 29, 2025, the City Council adopted the FY 2025/26 Municipal Fee Schedule (Resolution 25-9437) which included Pool Rental fees for Shared Facility and Exclusive Use:

**WHEREAS**, the City has conducted community outreach, a benchmark analysis and review of its field infrastructure needs;

**WHEREAS**, in accordance with the City's analysis and review, the City now desires to amend the Pool Rental Fees as detailed in the FY 2025/26 Adopted Municipal Fee Schedule.

## NOW THEREFORE, BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

- 1. That the City Council hereby finds that the above Recitals are true and correct and by this reference makes them a part hereof.
- 2. That the FY 2025/26 Municipal Fee Schedule is hereby amended to modify the Parks and Recreation Department's Pool Rental Fees as follows:

Priority User Group 2	-	\$8 per hour per lane

Priority User Group 4	-	\$16 per hour per lane
Priority User Group 5	-	\$20 per hour per lane
Priority User Group 6	-	\$40 per hour per lane
Priority User Group 7	-	\$40 per hour per lane

- 3. The fees described in Section 2 of this Resolution shall replace the Pool Rental fees contained in the FY 2025/26 Adopted Municipal Fee Schedule (Resolution 25-9437).
- 4. In order to implement the fees described herein, Council shall establish through separate action(s) descriptions for each Priority User Group Category.
- 5. Effective date. This Resolution shall take effect immediately.
