Parks & Recreation Commission Work Plan Goals for FY2022/23 7. 23-735

**Recommendation:** Report on activities and efforts in support of the Commission's Work Plan Goals for FY 2022/23.

Work Plan Goals:

A: 1) Review park site and facility condition assessments and recommend priorities given existing and anticipated service levels and available resources;

Subcommittee: Vice Chair Caldwell, Commissioner Field, and Chair Cox. Status as of 07/18/2023: Commissioner Chu advised the Commission that there are a lot of public input during the Council Meeting regarding ISC. Waiting for the Forensic Study.

B: 1) Review and solicit community input on the existing City park rehabilitation projects based on the current Capital Improvement Program (CIP) Budget and schedule; and 2) Review residential developer proposed schematic designs for new neighborhood parks that serve new residential development;

Subcommittee: Commissioner Chu and Commissioner Hai. Status as of 07/18/2023: Working on the landing page with IT, QR code pending. No further update at this time.

C: 1) Host and develop recommendations for the annual Santa Clara Art & Wine Festival 2023; and 2) participate in Citywide Special events Subcommittee: Chair Cox, Commissioner Field and Commissioner Forte. Status as of 07/18/2023: Manager Castro reported that merchandise for sale will be a commemorative wine glass, purchase optional for collectors. Beer and wine will be served in disposable and compostable cup. Commissioners have a choice of volunteering at the merchandise, information, or entertainment support booth.

D: 1) Partner with at least one other City commission to build on/expand at least one existing Parks & Recreation event by adding one extra element for patrons to interact with during the event.

Subcommittee: Commissioner Forte and Commissioner Ricketts. Status as of 07/18/2023: No update at this time.

### STAFF REPORT

Director Teixeira informed the Commission about the newly appointed Commissioner, Vikas Gupta, Santa Clara Swim Club member. Director Teixeira also announced his retirement as of September 29, 2023 after almost 15 years with the City and 28 years of combined service with other cities; 13 years with non-profit, faith-based, and youth and young adult ministries. A national search will be done for the new Parks & Recreation Director. The Director introduced Park Managers Lupe Fuentes and Doug Abernethy. Lupe Fuentes is acting as the Cemetery Operations lead since Phil Orr's retirement.

**Recreation Manager Castro** reported on the additional Senior Center Hours as follows:

Facility & Fitness Center, Monday & Wednesday until 7 pm; Saturday, 8 am - 12 pm; Natatorium, open 6 days per week. The Park Projects page has the links to the online survey for Henry Schmidt Park and Warburton Park. Upcoming events: Concerts in the Park at Central Park, Street Dance, and Sunset Cinema.

**Park Manager Abernethy** reported that Montague Playground is now open, and the Department continues to work with contractors to finish the Montague Park building. Eddie Souza building has been completely repaired and is open.

Park Manager Fuentes reported that the Parks Division now has 37 staff who are Certified Pool Operators. Magical Bridge All-Inclusive Playground construction continues, as scheduled. The City had a successful Fourth of July event in collaboration with other city departments. For the Art & Wine Festival, the Parks Division will replenish the mulch layer throughout Central Park. Director Teixeira shared that Park Manager Fuentes monitors all certifications for the Department.

### **COMMISSIONERS REPORT**

**Commissioner Chu:** Attended the Fourth of July event. She has had inquiries about fireworks recently. She is looking forward to the Art & Wine Festival. She also asked about how vendors are selected since there is a lot of interest from the community. **Manager Castro** stated that the information is available online.

**Chair Cox**: Attended the Fourth of July event. Asked about After-Party Event for Art & Wine Festival on Saturday, September 16, 2023. Suggested an agenda item for next month in relation to the end of Commissioner Field's tenure with Parks & Recreation Commission.

**Commissioner Field:** Learned a lot during his tenure in the Commission. If help is needed for Art & Wine, he would be happy to help.

**Commissioner Forte:** Attended the Fourth of July event and all the Concerts in the Park series in Central Park and Live Oak Park.

**Commissioner Hai:** Went to Lake Berryessa (Napa, CA) and commented that it is so beautiful.

**Commissioner Ricketts:** Attended Fourth of July event, and said it was awesome and fun. She is looking forward to other events to dance the night away. The Wade Brummal subcommittee will meet tomorrow (July 19).

### **MEETING DISCLOSURES**

The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision. Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. If a person wishes to challenge the nature of the above section in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Santa Clara, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.

If a member of the public submits a speaker card for any agenda items, their name will appear in the Minutes. If no speaker card is submitted, the Minutes will reflect "Public Speaker."

In accordance with the requirements of Title II of the Americans with Disabilities Act of 1990 ("ADA"), the City of Santa Clara will not discriminate against qualified individuals with disabilities on the basis of disability in its services, programs, or activities, and will ensure that all existing facilities will be made accessible to the maximum extent feasible.
