Discuss and Take Action on Youth Commission FY 2025/26 Work Plan & Goals

At the January 13th meeting, the Youth Commission continued discussions regarding its work plan priorities and goals for the FY 2025/26 term. Commissioners developed mission statements for each committee to align with their work plan goals.

1. The **Community Building Committee** aims to foster a culture of inclusion, belonging, and connection among the Santa Clara youth through bonding events and collaborative opportunities. On Friday, January 16, the Commissioners will be partnering with the Youth and Teen Center's "Kids Rock" event to record the debut interviews for their "We Are Santa Clara" Instagram series. Simultaneously, preparations for the SC Hacks hackathon event are moving forward with the completion of promotional flyers and sponsorship blurbs. The team plans to finalize the event's theme shortly to begin official outreach to schools and corporate sponsors. Their goal is to have all registration and sponsorship information distributed within the next few weeks.
2. The **Youth Empowerment Committee** seeks to empower Santa Clara youth through various projects, including panels highlighting local voices and activities that create opportunities for community service. The committee has finalized the script for the upcoming project, "What Can You Do with a Library Card?" Committee contacted the City's Teen Library Videos team, and the group collaborated on promoting the Teen Library Card Design Competition.
3. The **Civic Engagement Committee** seeks to facilitate community outreach and education while providing better accessibility to city resources. Its goal is to broaden the awareness of Santa Clara's youth by highlighting essential services and information. The committee has developed a draft Spanish version of the "Welcome Resident" packet and a Canva flyer, alongside a strategy for broader promotion. Youth Services Librarian Lorena Romero provided guidance on the specific protocols required for the library to host and post these materials. With these resources finalized, the team is shifting its primary focus toward the upcoming Narcan demonstration event.

STAFF REPORT

Lorena Romero, Youth Services Librarian, reported on upcoming events and resources for teens. Highlights include the Library Card Design Contest, a STEM Zone event on April 19th, and an upcoming Comic-Con event on October 10th.

Gayle Ichijo, Recreation Supervisor, followed up on several items previously emailed to the Commission: the CPRS YTRS scholarship application; the upcoming YTRS conference, "YAC Attack," on March 7th; and the MLK Jr. Choral Reading taking place January 14th in the Central Library's Redwood Room (interested participants should contact Rachel Schmidt). Additionally, she shared an invitation to the Super Bowl Flag Raising ceremony at Levi's Stadium on January 22nd.

COMMISSIONERS REPORT

On December 12, 2025, during Assemblymember Patrick Ahrens' Holiday Open House, **Commissioner Israni** met with Delia, a representative from Santa Clara County Social Services (SCCSS), to discuss urgent updates regarding healthcare access. The conversation highlighted important information and a critical upcoming deadline for undocumented individuals, including minors, who are currently enrolled in Medi-Cal.

Commissioner Gopisetti is collaborating with the Santa Clara Schools Foundation to launch a financial literacy workshop series tailored for elementary-aged students in Title 1 after-school programs within the SCUSD. The initiative involves interactive activities and storytelling to teach foundational financial skills. She is currently seeking fellow commissioners to volunteer for these sessions to assist with reading and student engagement.

Commissioner Madriaga reported on the successful Wilcox High School annual toy drive, which was relocated this year to Buchser Middle School to better serve a higher-need student population; the event ensured every participating child received two gifts. Additionally, student leaders from Santa Clara, Macdonald, and Wilcox High Schools met during the winter break to plan the "Battle of the Schools" scheduled for Friday, April 10 at the Santa Clara High School main gym.

Commissioner Arias Hernandez has co-founded a new student advocacy group focused on increasing student representation and influence within the school district. The group has been actively collaborating with district officials to draft and revise formal board policies. Their next steps involve a high-level meeting with the Superintendent to further integrate student perspectives into district governance.

SUBJECT

Discuss and Take Action on Youth Commission FY 2025/26 Work Plan & Goals

BACKGROUND

The Youth Commission develops an annual work plan through discussions of current trends and civic needs that relate to the youth and teen population. The annual work plan drives the activities of the Commission throughout the term. The Commission established goals over the past few terms including promoting health and wellness, providing public outreach and education, and fostering community inclusiveness.

DISCUSSION

The **Community Building Committee** is launching its "We Are Santa Clara" Instagram series with debut interviews at the "Kids Rock" event which took place on January 16. Simultaneously, the team is finalizing the theme and promotional materials for the SC Hacks hackathon to begin outreach to schools and sponsors within the coming weeks. These initiatives support the committee's broader mission of fostering inclusion and connection among Santa Clara youth.

The **Youth Empowerment Committee** is finalizing its "What Can You Do with a Library Card?" project while collaborating with the City's Teen Library Videos team to promote a card design competition. These efforts, which include a completed script and upcoming logistical reviews, aim to provide community service and empowerment opportunities for Santa Clara youth.

The **Civic Engagement Committee** has finalized a Spanish-language "Welcome Resident" packet and promotional materials to improve youth access to city resources. With guidance from the Youth Services Librarian on distribution protocols, the team is now shifting its primary focus toward an upcoming Narcan demonstration event. These efforts align with the committee's mission to broaden community awareness and provide education on essential services.
