**GENERAL BUSINESS**

2. [24-627](#) Review Policy and Procedure 049 ("Community Grant Policy")  
(DEFERRED FROM JUNE 3, 2024)

**Recommendation:** Approve amendments, if any, to Policy and Procedure 049 ("Community Grant Policy") and bring forth to City Council for consideration and approval.

Staff presented on Council Policy 049 ("Community Grant Policy") and recommendations to amend the policy.

The Committee discussed the policy and provided additional proposed amendments including 1) Increase grant amounts to account for inflation, in a method to be determined by staff, and increase total amount of the program to compensate for inflation (Approved by Council in a budget process), 2) Reserve a portion of funds for later in the year for tournament type events, 3) Roll over balances from the program to the following year, 4) Consider term limits for suspension to be based on the severity of the infraction as well as organization change by which the infraction occurred, and 5) Require grantees to submit a post-event description which may be included on the City website.

The Committee approved the staff recommendations with additional proposed amendments.

**Committee Member Jain motioned to approve the staff recommendation, seconded by Committee Member Park with additional proposed amendments from the Committee for Council Policy 049 ("Community Grant Policy")**

3. [24-628](#) Review Meeting Management Protocol Options and Rosenberg's Rules of Order and Provide Direction to Staff (DEFERRED FROM JUNE 3, 2024)

**Recommendation:** Provide Direction on a Council Policy for Meeting Management Protocols Recommendations by the Governance and Ethics Committee and Forward for Consideration and Approval by the City Council

Staff presented options to consider for meeting management protocols including Rosenberg's Rules of Order. **Committee Member Park** recommended the enforcement in the application of rules and to also consider options for opportunities for robust discussions, to not place time limits and limiting rounds of number of questions.

Member of the public **Tom Shanks** stated public comment at the end of a meeting is a concern as many are exhausted and few people are listening. Member of the public **Wanda Buck** commented on efficiency for meeting management.

**Committee Member Jain motioned and seconded by Committee Member Park for staff to return to the Committee with a policy on Rosenberg's Rules for Meeting Management Protocol and recommended establishing public comment sections at the beginning and at the end of a meeting, at the Chair's discretion, with a time limit for the first round of public comments, and the balance of the public comments to be heard at the end of the meeting.**

The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision. Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. If a person wishes to challenge the nature of the above section in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Santa Clara, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.

If a member of the public submits a speaker card for any agenda items, their name will appear in the Minutes. If no speaker card is submitted, the Minutes will reflect "Public Speaker."

In accordance with the requirements of Title II of the Americans with Disabilities Act of 1990 ("ADA"), the City of Santa Clara will not discriminate against qualified individuals with disabilities on the basis of disability in its services, programs, or activities, and will ensure that all existing facilities will be made accessible to the maximum extent feasible.
