- Homekey is a State initiative to rapidly expand housing for those experiencing homelessness or are at risk of homelessness. Projects are granted funding and streamlined process.
- · Interim housing supports the transition from homelessness to permanent housing
- Homekey awards are issued by State's Housing & Community Development (HCD)
- November 2021 County Board directed County Office of Supportive Housing (OSH) to identify potential sites for interim housing
- November 9, 2021 City Council study session on potential HomeKey applications with Bella Vista and White Oak Lane. Council provided direction to continue working with LifeMoves to identify a Santa Clara site
- April October 2022 Homelessness Taskforce identified need for interim housing

- February March 2023 Community Outreach Meetings

- June 27, 2023 City Council Adopted FY 23/24 Operating Budget, appropriated funds to the Lawrence/Benton project
- July 2023 County submitted Homekey application for Lawrence/Benton project to State's HCD
- April 3, 2024 City Council identified Providing Interim Supportive Housing and Outreach Services for Unhoused as a Council Priority

Homekey Program Update

- HCD has awarded \$818,000,000 to 49 projects since 2023
- HCD is interested in funding the Lawrence/Benton Project
- HCD requested funding identified in the Homekey application be reconfirmed

- Next Program Homekey+ is not for families or interim housing but for permanent supportive housing for veterans or individuals with mental health or substance use challenges





Hello Mayor and Council,

I just learned about this project on Nextdoor. It seems that many people oppose this due to "safety or financial concerns". However, I am very excited to hear about this project, and I believe safety and finances can be managed by the experts.

I was born and raised in Santa Clara, and I'm thankful that I have never been homeless. But I speak to homeless people around our city, and I know many individuals who need housing and case management. I would like to share a few stories.

There is a woman named Candie who lives in her car in a parking lot in my neighborhood. She applied for housing assistance over a year ago, but has yet to receive any support. Her children attend school in Santa Clara, but they live with a family member since she does not have housing. She has struggled a lot, including with drug addiction, but has been clean over two years. She got a job at McDonald's and has been working hard to improve her life. But there are days where the struggle is overwhelming. If you can provide support, it would mean the world to her, and her children.

There is a man named Ramon who often stays in Central Park, but sometimes goes closer to Lawrence Expwy. If you saw him, you might not realize that he's homeless because he takes good care of his appearance, but then you may see him carrying a suitcase wherever he goes. He stays to himself, and doesn't cause any trouble, or drink or do drugs, and is so kind and humble. Yet he was attacked at a 7-11 in September, for simply asking for help. He lost his housing a few years ago, but doesn't have access or knowledge of resources to get back on his feet.

There is another man named Steven who usually stays behind Dennys by City Hall, but frequents Panera and Pete's coffee for a place to sit and access the internet on his tablet. I helped him with clothing and luggage many months ago, but it was later stolen by another homeless person, so I helped him again. He is so gracious and resilient. He has access to a case manager in Mountain View, but has no support in Santa Clara.

All of these people need support. They need case managers and help to get back on their feet. They need cell phones, safety, and other basic needs. They are not dangerous. I see them often enough to know them by name, and I help them in any way that I can. Sometimes I buy them food, other times I help with clothes, hygiene, and other essentials, or just kindness and encouragement. When I am out with my children and I see them, I introduce them to my children. These are not people to be scared of.

I do understand that community members are worried about safety and financials. However, I believe that these issues can be managed, and helping the homeless should be a financial priority. It's sad that many people paint the homeless as dangerous. Many won't even talk to homeless people, almost as if homelessness is contagious. Sure there are some who are dangerous, on drugs, or commit crimes, but that applies to people with housing as well.

In September, I volunteered with church friends to serve the homeless in St. James Park in San Jose. Over the course of 4 Friday afternoons, we served over 400 people with food, toiletries, clothing, blankets, and more. I witnessed the needs first hand, and heard many stories of individuals and families struggling with homelessness. I see homeless people in Santa Clara every day, and I'm sure you do too. But I don't know of any places in Santa Clara where they can get help. I have called homeless resource lines for some of these people in Santa Clara, and the resource lines tell me to have the people call or go to offices in San Jose. However, most of these homeless people do not have phones or transportation, so they have no way to call or access the services.

I really hope that you can find a way to make this program happen and help homeless individuals and families as soon as possible. Some residents may be against it, but I beg you to do what's right. These people need help. In addition to this, I ask you to consider other ways to reach out to the homeless in our city, and assist them with basic services like cell phones and case managers. And lastly, when you see a homeless person, smile and say hello. Treat them with dignity and respect.

To the Mayor and City Council of Santa Clara -

After narrowly voting to pass the Homekey project in May 2023, I applauded the City Council declining to sign on as a co-sponsor to Project Homekey's development at Benton and Lawrence later than summer.

I'd hoped that would be the end of it, but I see Project Homekey lives.

My concerns remain the same about the facility:

- Safety risks for the surrounding neighborhood and the children that live here and attend school nearby.
- Negative impact to nearby property values.
- A temporary / permanent shelter is already being developed within 0.5 miles in the former Bella Vista Inn at El Camino and Lawrence Expressway. We should get that shelter up and operational to see its impacts before adding another so close by.
- The cost!

The cost is exorbitant for what you're getting: \$34M for 30 units on land that Santa Clara already owns, and \$3.5M dollar annual operational budget. If you're spending over \$115K/yr for each unit running the place, it seems like you could just give the prospective residents the same money to get them off of the street temporarily and save the up front cost of building the housing. This would have the added benefit that the program could be shutdown if funding runs out.

If this is intended to be either a mental health or substance abuse treatment facility, then it should be presented as such.

Judging from the fact that Santa Clara has put the \$400M Measure I on the ballot this coming year, that indicates to me that the city does not have the funding for this program. If the City is to move ahead with Project Homekey on Benton, I certainly would not be inclined to approve Measure I since that funding may very well be used to pay for Project Homekey.

Please do what's right for the community and decline funding for this poorly conceived project.

As you know, tomorrow you will be voting to appropriate the already agreed upon money to go towards the potential Benton / Lawrence Interim Housing Project. You may remember that this was previously included in the FY 23/24 budget, which passed unanimously.

A letter is attached to this email expressing our support and gratitude for these actions, with a broad coalition of supporting organizations included.

In addition to reading through the comprehensive agenda packet created by your staff for this meeting, members in our group did additional research to clarify some questions that we have heard from the Council and other leaders. The primary concern you have shared is funding. We hope that the summary below, currently our best understanding of how matters stand, resolves that concern. We also know that you can't put a price on the welfare of children who will one day live in this building.

We also encourage you to review the resources we created in 2023, including 16 Reasons why we support this project, backed by evidence and research.

Thank you, and we look forward to seeing you at the Council Meeting tomorrow evening.

P.S. We promise to do our part to not create another 7 hour meeting

As the City decided not to be a co-sponsor of the Homekey application, there are no agreements currently in place between the City and either the State or with the County/LifeMoves that commit the city to spend any funds on the Lawrence/Benton interim housing project.

The letter sent to the County from the City Manager on June 14th 2023 (in accordance with the City Council's votes the previous month) formally acknowledged a commitment to allocate up to \$7M, a combination of City Budget operating funds and PHLA funds, over a period of 7 years towards the operation of the facility if and when it is built. The letter, provided in the agenda packet, indicates that a **Revenue Sharing agreement**, requiring a **restrictive, recorded covenant**, would in due course have to be negotiated between the City, County and LifeMoves, and approved by the City before any forthcoming offer of funding from Homekey could be accepted. The revenue sharing agreement would spell out all the financial details of the commitment between the City and the County/LifeMoves, and the covenant would clearly define all the restrictions on use, operations and occupancy by families, etc that would be binding on the City and the County/LifeMoves.

On June 27th 2023, in the annual budgeting process, the Council voted to confirm that up to \$7M budget allocation.

Now, more than a year later, the project applicants, the County and LifeMoves, have been notified that Homekey is interested in funding the project, but because of the length of time that has passed, the budget allocation by the City - estimated slightly lower than before, at \$6.6M over 7 years - must be reconfirmed before a formal award from Homekey can be offered. If that reconfirmation happens, a HomeKey offer would be forthcoming, and the City staff would negotiate with the County and LifeMoves to create the Revenue Sharing Agreement and restrictive covenant, which would then be brought back to the Council for approval. After approval, the project applicants could proceed to accept the Homekey funding.

So, two separate legal agreements are involved. One would be between the State and the County/LifeMoves. The other would be between the City and the County/LifeMoves. The City is in a position to craft the latter agreement (which does not exist yet) in a way that would satisfy its concerns, fiscal and operational. But there is very little time - probably no more than 2 months - to get this done.

Hello Mayor and City Council Members,

I am a mother with two elementary school kids living in City of Santa Clara. My whole family opposes the proposed Homekey Interim Housing Development Plan (Benton Shelter Plan) because LifeMoves, who supervises the project, has a very bad record of running other homeless shelters in nearby cities.

I worked in civil engineering industry for more than a decade and in several countries. With the record and performance of LifeMoves, I doubt they could earn any projects without bribery in any countries.

LifeMoves supervised similar shelter projects in the nearby cities, and they created very poor records in achieving projects' goals. For example, the construction cost estimate of LifeMoves' one shelter was doubled within a year after the approval date, however, the average inflation rate was 5%-7% per federal and state government's reports. Does this unreasonable construction cost increase indicate LifeMoves is losing control of their projects? The intention of shelters is to provide a safe place for many homeless people to live. However, LifeMoves kept harassers in the shelter despite multiple harassment reports per local news. How can they achieve the purpose of the project by keeping the harassers in the shelters and leaving well-behaved homeless people out of the shelters due to the threats by harassers.

Per local news, the success rate of LifeMoves' shelters is only 26%, and they lack qualified staff and nurses to operate their existing shelters even though the shelters have not reached their full capacities up to now. How can we trust LifeMoves is able to provide qualified service for the existing shelters and has resources to operate new shelters? Without resolving the problems with the existing shelters but rushing to construct another new bigger shelter will only make the problems worse. We are afraid the proposed Benton Shelter Plan will be another non-successful project by LifeMoves.

The City of Santa Clara is raising money to operate the city's facilities not to be wasted by LifeMoves. The City should has accountability for spending tax money. If the City moved funding of projects that service residents' needs to the Benton Shelter project, taxpayers would be very disappointed and would vote No to Measure I to stop the waste of tax money!

We voted for our city council members in the trust that we would work together to make the City of Santa Clara a better place to live. We only vote for whoever can reflect our interests.
