## REPORT TO CIVIL SERVICE COMMISSION SUBJECT

Action to Abolish the Eligible List for Associate Engineer (Civil) (Job Code 321)

### **ACTION AND AUTHORITY**

The Associate Engineer (Civil) (Job Code 321) classification is used in the Department of Public Works (DPW) and the Water & Sewer Utilities Department (Water & Sewer). There is currently an eligible list for Job Code 321.

Eligible lists generally shall remain in force for a period of one year (if not extended) for non-sworn positions, pursuant to Civil Service Rules, Sec. 4.3. The Water & Sewer Utilities Department and Department of Public Works is requesting to abolish the Associate Engineer (Civil) (Job Code 321) eligible list based on the authority of Civil Service Rules, Sec. 4.8(a), which states, Eligible Lists may be abolished by the Director of Human Resources either, "If the list contains fewer than five (5) names, or "Notice of abolishment of an eligible list shall be mailed to all eligibles whose name appear on the list, at time of recruitment to establish a new list."

### **DISCUSSION**

Under direct supervision, the Associate Engineer (Civil) performs field and office work in design, construction and/or maintenance programs; provides technical assistance in the implementation of plans and programs; and may work with the public and consultants on various projects providing guidance and information. This classification is a journey level professional engineer expected to perform the full range of professional engineering duties. Incumbents may exercise direct supervision over professional and paraprofessional engineering staff.

Both Water & Sewer Utilities and Public Works departments conducted a recruitment in February 2025 to initially fill two (2) vacancies; one (1) in DPW (Land and Property Division) and one (1) in Water & Sewer. Due to promotions in both departments that recently occurred, there are now three (3) vacancies; two (2) in DPW (Land and Property Division and Traffic Engineering Division) and one (1) in Water and Sewer. Currently, an eligible list comprised of ten (10) candidates was established in April 2025. In total, three (3) candidates were hired from the eligible list; two (2) candidates were hired in DPW and one (1) candidate was hired in Water and Sewer. At this time, there were seven (7) candidates remaining on the eligibility list.

After the hiring as described above, one (1) candidate requested to be removed from the eligible list after being extended an offer and declining the offer, and another candidate was offered one of the Associate Engineer (Civil) positions, but declined the offer since they accepted a higher level position in their current agency and requested not to remain on the eligible list. At this point, there remains five (5) candidates remaining on the eligibility list.

All five (5) candidates currently on the eligible list were interviewed by both the Water & Sewer Utilities and Public Works departments seeking to identify candidates for the current openings which require two (2) years of experience in civil engineering office and field work, experience with water or wastewater infrastructure, and other desirable qualifications. Only one (1) candidate was interested in being interviewed for present vacancies and the other four (4) declined. After considering the qualifications necessary for the current opening, the departments did not elect to extend an offer to the candidate.

The eligible list is currently set to expire on April 1, 2026. After receiving approval to abolish the eligible list, Human Resources will conduct another recruitment and create a new eligible list for Associate Engineer (Civil) (Job Code 321).

Action to Modify the Jail Service Officer (Job Code 353) Examination Weighting Plan to 100% Oral Examination, and Qualifying Written and Performance Examination on an Ongoing Basis

#### **ACTION AND AUTHORITY**

The Human Resources Department coordinated with the Police Department and is requesting Commission approval to modify the examination weighting plan for Jail Service Officer (Job Code 353) on an ongoing basis. This request is based on the authority of Civil Service Rule 3.1, "The Commission shall determine whether the examination shall consist of a written, oral, or performance, or psychological, investigative, physical test, or any combination thereof, and shall indicate the procedure in the announcement."

The Jail Service Officer (Job Code 353) is responsible for a variety of tasks including operating the temporary detention facility, fingerprints and photographs arrestees in the booking process, conducting searches and inventory of property, monitoring building security console, maintaining detention records and releasing prisoners as authorized.

### **DISCUSSION**

The Human Resources Department and Police Department recommends modifying the examination weighting plan for Jail Service Officer (Job Code 353) on an ongoing basis. Currently, the examination weighting plan consists of 100% oral examination and qualifying written examination. The proposed modification is to add a qualifying performance examination. The addition of the performance examination would require candidates to submit proof of completion of a physical test, Work Sample Test Battery (WSTB). The WSTB test includes the following components: obstacle course agility run, body drag, chain link fence climb, solid fence climb, 500 -yard run, and 1.5 mile run. This is the same physical test that is required of Recruit Police Officers to submit at time of their application.

The Jail Service Officer classification requires employees to "engage in physically strenuous activities, including: using physical techniques to control persons, pushing or shoving persons to defend self, wrestling people to the ground, breaking up fights between people, operating fire extinguishers or other fire equipment." Additionally, Jail Service Officer's are required to complete a Corrections Academy (Adult Corrections Officer Core Course) during their probationary period. During the most recent recruitment process, the hired candidate was not able to complete the physical components required during the academy and resigned from City service within the first week of employment. Another employee, who did pass the academy, struggled through the physical component of the academy. Given the physical nature required by the job and the resources spent for candidates to complete a full backgrounding process, the City is recommending to modify the weighting plan to require candidates to pass the WSTB and submit proof at time of application. This will assist the City with moving candidates forward in the recruitment process will have the best chance of being successful in completing the Corrections Academy.
