# **Compensation Adjustments**


- Effective July 1, 2025

#### **Public Hearing**

- Solid waste customers may submit oral or written protests until the close of the Public Hearing
- At close of Public Hearing, protests are tabulated
  - -35,911 notices were sent on April 11, 2025
  - -If protests tabulated are 50 percent plus one (17,956), the proposed fees cannot be imposed
- If there is not a majority protest, Council can make and act on a motion to increase fees
