

**RESOLUTION NO. 22-9112**

**A RESOLUTION OF THE CITY OF SANTA CLARA,  
CALIFORNIA AMENDING THE "CITY OF SANTA CLARA  
2022/23 MUNICIPAL FEE SCHEDULE" REGARDING  
UPDATED LIBRARY COMMUNITY ROOM RENTAL FEES**

**BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:**

**WHEREAS**, under the provisions of the City of Santa Clara Charter, Municipal Code, Constitution of the State of California, and California Government Code, fees and charges assessed by the City of Santa Clara may be amended or modified upon the adoption of a Resolution by the City Council;

**WHEREAS**, the Library Department hosted a meeting with the Board of Library Trustees on April 28, 2022 to discuss the existing community room rental fees and determine adjustments to the fees; and,

**WHEREAS**, the City now desires to amend existing community room rental fees in the Library Department, as agreed upon with the Library Board of Trustees, in the FY 2022/23 Municipal Fee Schedule.

**NOW THEREFORE, BE IT FURTHER RESOLVED BY THE CITY OF SANTA CLARA  
AS FOLLOWS:**

1. That the City Council hereby finds that the above Recitals are true and correct and by this reference makes them a part hereof.
2. That the FY 2022/23 Municipal Fee Schedule last adopted on April 19, 2022, is hereby amended to update the existing room rental fees under the Library Department, under exemption 4 ("A charge imposed for entrance to or use of local government property, or the purchase, rental, or lease of local government property"), as shown on the attached Municipal Fee Schedule Change – Library Fees document.

3. Effect of Fees Prior to effective Date of Resolution. This Resolution shall not be construed so as to affect any fee or charge payable or paid under any applicable fee schedule operative prior to the effective date of this Resolution.

4. Effective date. The fees set forth in the "CITY OF SANTA CLARA 2022/23 MUNICIPAL FEE SCHEDULE" shall be effective on July 1, 2022.


