# AMENDMENT NO. 1 TO THE REIMBURSEMENT AGREEMENT FOR SPECIFIC PLANNING AND ENVIRONMENTAL PLANNING SERVICES FOR THE PATRICK HENRY DRIVE SPECIFIC PLAN

#### **PREAMBLE**

This agreement ("Amendment No. 1") is entered into by and among the City of Santa Clara, California, a chartered California municipal corporation (City) and CLPF – 2901 Patrick Henry, L.P., Pearlman Himy, I LP, Patrick Henry Recovery Acquisition LLC, 3055 Patrick Henry Development LLC, 4590 Patrick Henry LLC, International Asset Holding Company, Drawbridge 4600 Patrick Henry, LLC, Bigler Trusts, Pactron, Dollinger Patrick Henry Associates, and Marriott Center Owners Association (collectively, "Applicants"). City and any of the Applicants may be referred to individually as a "Party" or collectively as the "Parties" or the "Parties to this Agreement."

#### **RECITALS**

- A. Several of the Parties previously entered into an agreement entitled "Reimbursement Agreement for Specific Planning and Environmental Planning Services for the Patrick Henry Drive Specific Plan," dated July 17, 2018 ("Agreement"); and
- B. The Parties entered into the Agreement for the purpose of having Applicants fund the preparation of a Specific Plan for the Patrick Henry Drive plan area and the Parties now wish to amend the Agreement to recognize changes in developer interests, incorporate Amendment Nos. 1, 2, and 3 to the Professional Services Agreement with Moore, Iacofano & Goltsman, Inc. as part of the Service Agreement, include additional consultant costs for the Pump Station Analysis, and update the cost allocation for each Party to this agreement.

NOW, THEREFORE, the Parties agree as follows:

#### AMENDMENT TERMS AND CONDITIONS

- 1. Marriott Center Owners Association is hereby added as a Party to the Reimbursement Agreement and subject to the rights and responsibilities therein.
- 2. 4590 Patrick Henry LLC is hereby added as a Party to the Reimbursement Agreement and replaces all rights and responsibilities previously assigned to The Sobrato Organization.
- 3. Attachment A, entitled "Agreement for Services Between the City of Santa Clara, California, and Moore Iacofano Goltsman, Inc." dated August 31, 2018, is hereby appended with the attached Amendment Nos. 1, 2 and 3, and references to the "Service Agreement" in the Agreement shall now be interpreted as including such Amendment Nos. 1, 2, and 3.

- 4. The City is utilizing Woodard and Curran to perform sewer modeling and a pump station analysis. These services and related costs are hereby incorporated into the Reimbursement Agreement as Amended as eligible consultant costs.
- 5. The allocation of costs for all Parties to this Agreement is hereby updated by replacing Attachment B, entitled "Patrick Henry Drive Owners Cost Allocation Table" with the attached "Patrick Henry Drive Owners Cost Allocation Table Revision 4."
- 6. Article VI, Section G, of the Agreement, entitled "Notices" is amended to read as follows:
