**A RESOLUTION OF THE CITY OF SANTA CLARA, CALIFORNIA
FOR EXCEPTION TO THE 180-DAY WAITING PERIOD TO HIRE A
RETIRED ANNUITANT AS A TEMPORARY EXTRA HELP
EMPLOYEE (GOVERNMENT CODE SECTIONS 7522.56 AND
21224)**

BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

WHEREAS, in compliance with Government Code section 7522.56 the City of Santa Clara must provide CalPERS this certification resolution when hiring a retiree before 180 days has passed since his or her retirement date;

WHEREAS, Philip Waterhouse (CalPERS ID 3359575012) retired from the City of Santa Clara in the position of Senior Electric Meter Technician, effective December 23, 2021;

WHEREAS, section 7522.56 requires that post-retirement employment commence no earlier than 180 days after the retirement date, which is June 23, 2022, without this certification resolution;

WHEREAS, section 7522.56 provides that this exception to the 180 day wait period shall not apply if the retiree accepts any retirement-related incentive;

WHEREAS, the City of Santa Clara and Philip Waterhouse certify that Philip Waterhouse has not and will not receive a Golden Handshake or any other retirement-related incentive;

WHEREAS, the City of Santa Clara hereby appoints Philip Waterhouse as an extra help retired annuitant to perform the critically needed duties of Temporary Employee for the City of Santa Clara under Government Code section 21224, effective January 27, 2022;

WHEREAS, the entire employment agreement, contract or appointment document between the City of Santa Clara and Philip Waterhouse has been reviewed by this body and is attached herein;

WHEREAS, no matters, issues, terms or conditions related to this employment and appointment have been or will be placed on a consent calendar;

WHEREAS, the employment shall be limited to 960 hours per fiscal year;

WHEREAS, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal the hourly rate;

WHEREAS, effective December 26, 2021, the maximum monthly base salary for the Consultant position is \$34,666.66 and the hourly equivalent is \$200.00, and the minimum monthly base salary for this position is \$2,842.66 and the hourly equivalent is \$16.40;

WHEREAS, the hourly rate paid to Philip Waterhouse will be \$91.18; and

WHEREAS, Philip Waterhouse has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate.

NOW THEREFORE, BE IT FURTHER RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

1. The City of Santa Clara hereby certifies the appointment of Philip Waterhouse and that this appointment is necessary to fill the critically needed position of Temporary Employee for the City of Santa Clara by January 27, 2022. The retired annuitant was the former Senior Electric Meter Technician for the City of Santa Clara and will be rehired performing the comparable duties of the Senior Electric Meter Technician classification. The City would like to rehire Philip Waterhouse as an extra help to assist with complex meter installation projects for customers and for the Advance Metering Initiative on a part-time basis. This position will provide critical planning, process development and physical project completion as the City recruits to fill a vacancy in the Electric Meter Shop.

2. Effective date. This resolution shall become effective immediately.
