A RESOLUTION OF THE CITY OF SANTA CLARA, CALIFORNIA, AMENDING THE "CITY OF SANTA CLARA 2024/25 MUNICIPAL FEE SCHEDULE" TO UPDATE PARKLAND IN-LIEU FEES FOR NEW RESIDENTIAL DEVELOPMENT

**WHEREAS**, under the provisions of the City of Santa Clara Charter, Municipal Code,
Constitution of the State of California, and California Government Code, fees and charges
assessed by the City of Santa Clara may be amended or modified upon the adoption of a
Resolution by the City Council;

WHEREAS, on April 23, 2024, Council adopted the FY 2024/25 Municipal Fee Schedule which included Parkland In-Lieu Fees for New Residential Development that were unchanged;
WHEREAS, in accordance with City Code Chapter 17.35, the City has updated the average per-acre land values, occupant density data, and park development per capita values, adjusted by the California Construction Cost Index, that are used to calculate the Parkland In-Lieu Fees; and

WHEREAS, the City now desires to amend existing Parkland In-Lieu Fees for New Residential Development in the Parks and Recreation Department in the FY 2024/25 Municipal Fee Schedule.

## NOW THEREFORE, BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

- 1. That the City Council hereby finds that the above Recitals are true and correct and by this reference makes them a part hereof.
- 2. That the FY 2024/25 Municipal Fee Schedule last adopted on April 23, 2024, is hereby amended to update the existing Parkland In-Lieu Fees for New Residential Development under the Parks and Recreation Department, as shown on the attached City of Santa Clara 2024/25 Municipal Fee Schedule Parks and Recreation Department, Parkland In-Lieu Fees document.
