How we control the Drinking area

- One drink at a time and no stacking drinks.
- A container of alcohol will have no more than 12 ounces of beer or cider or 6 ounces of wine.
- All alcoholic beverages will be served in distinctly identifiable containers. Wine in plastic wine glass, beer in clear glass – neither to be used for anything else.
- All drinkers MUST be logged on the daily drinker log.
- Once a patron drinks, they can no longer jump.
- There will be a 2 drink maximum for alcoholic beverages per person.
- If we see signs of intoxication we do not sell.
- Second drinks will be logged on the Daily Drinker Log.
- Second drinks will be hole punched into their wrist band.
- Staff will walk through the facility every 20 minutes to monitor patron behavior and pick up the areas for any unattended alcoholic beverage containers.
- No alcohol served when Cosmic Lighting is on.
- All permitted service staff MUST always have their permit in the building.
- All permitted service staff must sign this document and return to Office Asst.
- Alcohol service will be discontinued at 8pm daily. All glasses must be removed before 9pm and before any cosmic lighting.
- All Servers will have gone through alcohol awareness server training (i.e., TIPS, TOPS)
- Regarding handling violent or disruptive patrons- Manages asks patron to leave and if we have any issues we call the local police.
- No Las Call
- No Happy Hour

ID all customers / No ID, No Drink / Exceptions with Manager Approval Only

Every customer must be asked "How old are you?"

All alcoholic beverages will be served in distinctly identifiable containers. Wine in plastic wine glass, beer in clear glass – neither to be used for anything else.

A (COLOR) wrist band will be used for those 21 and over when ID is checked for alcohol purchased.

Alcohol service will be discontinued at 8pm daily. All glasses must be removed before 9pm and before any cosmic lighting.
