THIRD AMENDMENT TO AGREEMENT NO. CW2239572 BY AND BETWEEN THE COUNTY OF SANTA CLARA AND BOSCO OIL COMPANY DBA. VALLEY OIL COMPANY

This is the Third Amendment to the agreement between the County of Santa Clara (“County”) and Bosco Oil Company dba. Valley Oil Company (“Contractor”), effective January 12, 2021, and as amended from time to time (collectively, the “Agreement”), to provide Unleaded Fuel 87 Octane for the County. The County and Contractor may be referred to herein individually as a “Party” and collectively as the “Parties.”

This Amendment is covered under Resolution BOS-2024-120, adopted by the County of Santa Clara Board of Supervisors on September 24, 2024 (legislative file 121759), and providing for the Delegation of Authority to the Chief Executive Officer or designee relating to the potential purchase of Regional Medical Center and related assets.

The Parties agree as follows:

1. **Amendment Effective Date.** This Third Amendment is effective as of the date it is fully executed as set forth below (the “Amendment Effective Date”).
2. Key Provision, AUTHORIZED USER, is amended to add the following County site:
