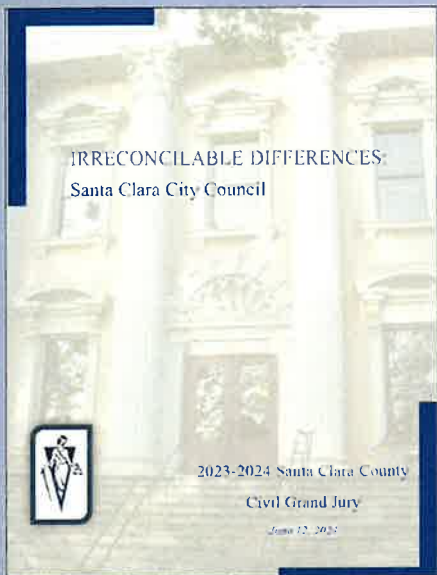


# Santa Clara Council Meeting – July 9, 2024

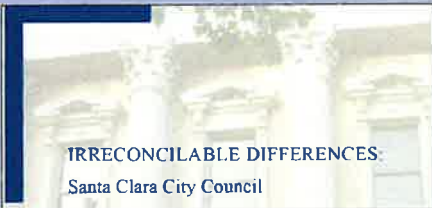

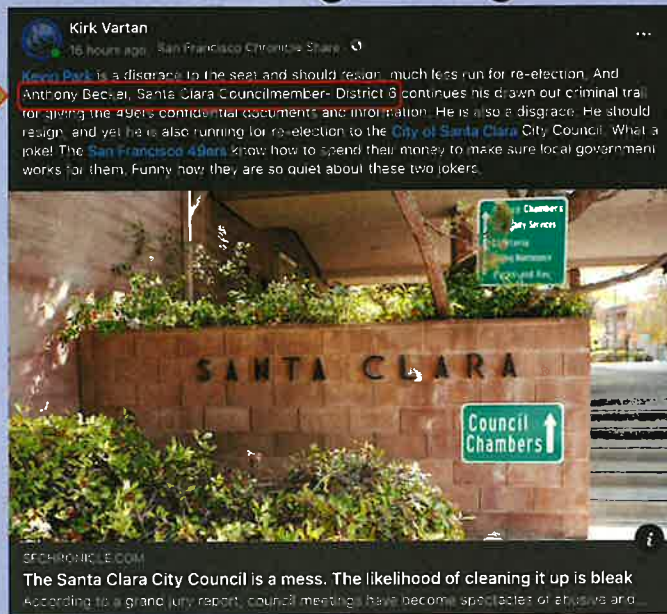

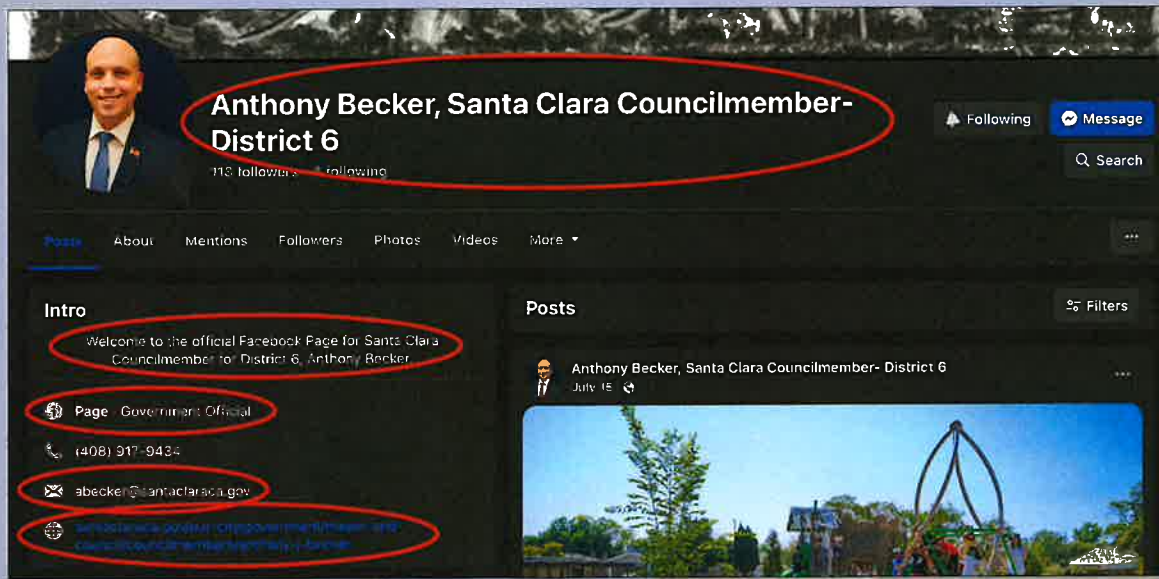
