Also, Park agreed with Reed to engage Pete Constant to interfere with the contract between the city and the 49ers, a violation of the Brown Act.


Constant cannot by law be given private details regarding closed session matters. Park was trying to violate Charter Section 807 by engaging a non staff member in city manager issues.
