Thank you, Ms. Pimentel. Though I will try to attend tonight, to be safe I am forwarding you my comments.

Here they are:

Good evening, my name is Victor Ojakian, and though I co-chair the Santa Clara County's Suicide Prevention Oversight Committee, I am here speaking on behalf of myself, as a suicide preventionist.

I have a dual purpose in communicating tonight. One is to request this City Council agenda and adopt a city suicide prevention policy. The other is to let those listening to this meeting know suicide is preventable and many people in this county work to see individuals do not take their lives.

Counting school districts and cities in Santa Clara County, close to fifty governmental entities have approved a suicide prevention policy. In fact the City of Santa Clara is the only remaining city without this policy, so having this policy is not an anomaly. It is the norm.

A city suicide prevention policy should provide for city staff, but also community residence, needs. Often the City Manager's administration, the community service personnel, and/or police personnel have involvement.

For those unaware, suicide is the leading cause of death in the City of Santa Clara since 2018, dwarfing deaths by homicide and most other causes of death.

Santa Clara County adopted a suicide prevention strategic plan (2010) and has a robust implementation program. Several services/trainings are available with no fee charged. The crisis line number is 1-855-278-4204 and the crisis text line is the prefix word "Renew" 741741

One final comment, suicide prevention is everyone responsibility and, like some other public health matters, an all-hands-on-deck approach is needed.

Thank you and please agenda and approve a city suicide prevention policy.
