- 1. Council Policy 006, entitled "Guidelines for City Commissions, Boards and Committees for Attendance at Conferences and Training Events", attached here as Attachment 1, is hereby approved and adopted commencing December 16, 2025 until further amended. The Policy shall continue in effect until otherwise affirmed, modified or terminated by vote of the City Council.
 - 2. Staff is directed to take such other actions as are necessary to implement, post and
