## RESOLUTION NO.

A RESOLUTION OF THE CITY OF SANTA CLARA, CALIFORNIA TO ADOPT THE MITIGATED NEGATIVE DECLARATION AND THE MITIGATION MONITORING AND REPORTING PROGRAM FOR THE PROPOSED AMENDMENT TO THE APPROVED RESIDENTIAL PLANNED DEVELOPMENT (PD) (PLN22-00505) LOCATED AT 1957 PRUNERIDGE AVENUE, SANTA CLARA

PLN25-00073 (Rezone)

**WHEREAS**, On February 19, 2025, SCS Development ("Owner") filed an application for the development of a 2.47-acre site located at 1957 Pruneridge Avenue, Santa Clara ("Project Site");

**WHEREAS**, the Project Site has a General Plan designation of Very Low Density Residential and is zoned Planned Development (PD);

WHEREAS, On March 19, 2024, the City Council approved the Owner's request to rezone the subject property from Public, Quasi-Public, and Public Park or Recreation (B) to Planned Development (PD) to construct the residential development with 22 detached two-story all-electric homes, private street and associated on- and-off-site improvements, and a Vesting Tentative Subdivision Map to subdivide the property into individual for-sale lots and four common lots for use as a utility corridor, vehicle access, landscape open space and bioretention areas (Approved PD);

WHEREAS, On March 19, 2024, City Council certified an Environmental Impact Report and adopted the CEQA Findings, Statement of Overriding Considerations, and the Mitigation Monitoring and Reporting Program for the 1957 Pruneridge Avenue Residential Project (Approved PD);

**WHEREAS,** on February 19, 2025, the Owner applied to amend the Approved PD to replace the approved electric stovetop appliances in the project with natural gas stovetop appliances ("Project") for each unit;

WHEREAS, in accordance with the Condition of Approval P23 of the Approved PD, installation

of natural gas infrastructure requires an amendment to the Approved PD zoning, and review by

the Planning Commission and approval by Council:

WHEREAS, to analyze the proposal to allow for the use of natural gas by replacing the

approved electric stovetops in the project with natural gas stovetop appliances, the City, as

Lead Agency, in tandem with Consultant 'David J. Powers' prepared an Initial Study ("IS") and a

Mitigated Negative Declaration for the proposed project in accordance with the California

Environmental Quality Act ("CEQA"), which was circulated for a 20-day review to public

agencies which have jurisdiction by law with respect to the Project, as well as to other interested

persons and agencies, and the City sought the comments of such persons and agencies

beginning on July 18, 2025 and concluding on August 7, 2025 ("Comment Period"); and

WHEREAS, a Mitigation Monitoring and Reporting Program ("MMRP") has been prepared for

implementation with Project development to reduce potentially significant impacts identified in

the Initial Study to less than significant; and

WHEREAS, the City through consultant 'David J. Powers' prepared written responses to the

comments received during the Comment Period and included these responses on the project's

CEQA page; and

WHEREAS, on October 8, 2025, the Planning Commission held a duly noticed public hearing,

at the conclusion of which, the Planning Commission recommended approval (6-0-0) of the

Mitigated Negative Declaration, the Mitigation Monitoring and Reporting Program, and

Amendment to the Approved Residential PD;

WHEREAS, on September 15, 2025, the notice of public hearing for the November 18, 2025,

Cit Council Hearing for this item was mailed to property owners within a 1,000-foot radius of the

Project Site boundaries; and

WHEREAS, pursuant to SCCC Section 18.146.020, on November 7, 2025, notices of the public

hearing of November 18, 2025, were posted at City Hall, the Central Park Library, the Mission

Branch Library, the Northside Branch Library, and on the City's website; and

WHEREAS, on November 18, 2025, the City Council held a duly noticed public hearing to

consider the Project, the MND, the MMRP, and all pertinent information in the record during

which the Council invited and considered any and all verbal and written testimony and evidence

offered in favor of and in opposition to the Project.

NOW THEREFORE, BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

1. That the City Council hereby finds that the above Recitals are true and correct and by

this reference makes them a part hereof.

2. That the City Council hereby finds that all potentially significant environmental impacts

that may directly or indirectly result from the Project would be reduced to a less than significant

level by implementation of the mitigation measures specified in the MND and MMRP.

3. That the City Council hereby finds that the MND is complete, prepared in compliance

with CEQA, and represents the independent judgment of the City Council.

4. That the City Council hereby finds that approval of this Project as mitigated will have no

significant negative impacts on the area's environmental resources, cumulative or otherwise, as

the impacts as mitigated would fall within the environmental thresholds identified by CEQA.

5. That the City Council hereby adopts the MND and MMRP for the Project as required by

the CEQA Guidelines (14 Cal. Code of Regs. § 15074).

6. That the City Council hereby designates the Director of Community Development as the

Custodian of Records for the Project, and the Planning Division at City Hall, 1500 Warburton

Avenue, Santa Clara, California, is the location of the documents and other material that

constitute the record of proceedings upon which this decision is based.

7. <u>Effective date.</u> This resolution shall become effective immediately.
