I, CECILIA AGUIAR, am hereby requesting to be placed on the Santa Clara City Council Agenda for the following purpose:

Cul-Del-sac (Dead End), Speed humps or similar traffic calming measures need to be instituted at the Cabrillo Ave and Lawrence Expressway. Along the 3583 to 3445 blocks of Cabrillo Avenue (between Lawrence Expressway and Nobili Avenue):

The excessive speeds of motorists, including Santa Clara School District buses, Commercial Heavy Weight Vehicles daily endanger the lives of the residents their families, (many of which with small children) as well as the resident's pets.

In addition, there have been multiple recent incidents of speeding that have resulted in costly damage to resident's parked cars. Noise is a daily problem caused by speeding vehicles, often exacerbated by the vibration of speeding vehicles that set off the car alarms of resident's vehicles that have been parked on the street. Our street is no longer safe and it is the duty of the City to provide necessary and effective traffic calming measures before a tragedy occurs.
