1. Please provide cost in all yellow-highlighted cells. All lines must be priced or clearly show "No Charge" or "Included", not left blank or zero.
2. All rates shall be inclusive, unless specified to the contrary, of all costs including all salaries, overhead costs, general and administrative costs, travel, and profit. Overhead costs shall include all tools, equipment, and related items that may be required to perform the work.
3. Do not include sales tax in your bid. Prior to award of contract, the City will confer with the successful Bidder(s) to review applicable sales and use taxes and make required adjustments.
4. Prices shall remain fixed for the initial one (1) year term. After the initial term, the City reserves the right to exercise four (4) additional one-year period extensions for a total of five (5) years. In the event the City elects to exercise options after the initial term, price adjustments may be considered by the City. The contractor must demonstrate to the satisfaction to the City that a price increase is justified.
5. The low price determination shall be based on the Total Base Bid Amount. Consideration for Local Business Preference will be applied to the score by the City if applicable.
6. In case of an error in the extension of prices in the bid, unit price shall govern and the City will re-calculate a corrected total.
