AMENDMENT NO. 1 TO THE AGREEMENT FOR SERVICES BETWEEN THE CITY OF SANTA CLARA, CALIFORNIA, AND UNIVERSAL SITE SERVICES, INC.

PREAMBLE

This agreement ("Amendment No. 1") is entered into between the City of Santa Clara, California, a chartered California municipal corporation (City) and Universal Site Services, Inc., a California corporation, (Contractor). City and Contractor may be referred to individually as a "Party" or collectively as the "Parties" or the "Parties to this Agreement."

RECITALS

- A. The Parties previously entered into an agreement entitled "Agreement for the Performance of Services by and between the City of Santa Clara, California, and Universal Site Services, Inc. for the 2017-2022 Janitorial and Pressure Washing Services at the Santa Clara Convention Center Complex, dated June 19, 2017 (Agreement); and
- B. The Parties entered into the Agreement for the purpose of having Contractor provide janitorial and pressure washing services, and the Parties now wish to amend the Agreement to extend the term of the Agreement for an additional year through June 30, 2023.

NOW, THEREFORE, the Parties agree as follows:

 - Unless otherwise set forth in this Agreement or unless this paragraph is subsequently modified by a written amendment to this Agreement, the initial term of this Agreement shall begin on the Effective Date of this Agreement and terminate on June 30, 2023.
- 2. Exhibit B of the Agreement, entitled "Fee Schedule" is hereby amended to read as shown in Revised Exhibit B, attached herein.
