- D. Celebrate! International Village update
 - i. Public statement regarding event:

Commissioner Bhatia updated the events happened around Celebrate International Festival over February. On February 15th, Commissioner Bhatia was notified by City Manager Deanna Santana, COO Walter Rossmann, and Assistant City Manager that the Celebrate (International Festival) was cancelled due to the lack of staff to support the planning and execution, and in addition lack of SCPD support due to a recently added 2nd Taylor Swift concert at the Levis Stadium in the case Mission College police needed SCPD assistance. When Mayor Gillmor came to know more about the event on Friday, February 16th, she stated to Commissioner Bhatia that the event would not be cancelled and instead rescheduled, likely later part of the summer, and she would champion the event going forward to ensure this doesn't happen again.

City Assistant City Manager, Ruth Shikada attended to share with the Commission the reason for the cancellation. She also expressed that the City leadership had read and understood our concerns as written in the Commission's Public Statement to City Manager and Staff regarding the Commission's concerns about International Festival cancellation for the 3rd time. So the Commissioners could evaluate if the letter needed to be submitted or presented. In addition, she stated that Jim Mercurio, VP of Stadium Operations and GM of Levis Stadium for the San Francisco 49ers, will

call the International Festival subcommittee Chair, Commissioner Bhatia, to discuss Celebrate SV International festival.

The Commissioners decided since the City leadership understood the concerns, the letter didn't need to be submitted as Public Statement in the Council.
