Mayor and Council,

I respectfully request that if Councilmember Becker decides to not attend tomorrow's meeting, that you NOT excuse his absence. He was not sick today at his arraignment. My understanding is when a council member is not able to attend, the council makes a motion to excuse the council member. If the only reason the council member is not present are the legal issues he faces, I would suggest that is not a good-faith reason to be excused.

He can of course choose not to attend the council meeting, but it should be marked as an absence. Self-inflicted legal issues that the City of Santa Clara are not responsible for should not be the business of this council. Everyone is innocent until proven guilty; I am not suggesting you can or should remove him from office. But he should continue to perform his elected duties, duties he is being paid for, and serve the people. Being present for council meetings is one of time duties. And the council should all be there in person, unless they they are sick.

If you excuse him, you should provide a reason for the excuse; the public deserves it.
