Nancy Biagini is retiring after forty years between Pacific Telephone & Telegraph and the Communications Workers of America (CWA); she has been actively involved in the CWA for twenty years; she served on nearly every committee in her Local and served as an Executive Board member and later as Secretary-Treasurer and Local President for CWA Local 942; and

WHEREAS,

Nancy Biagini has been driven to further expand her education and knowledge, by receiving her Bachelor's degree in Labor Studies and her Master's degree in Organizational Behavior and Knowledge Management at George Mason University; and

WHEREAS,

Nancy Biagini has been honored with numerous awards in her community for her activism, both within and outside of the labor movement, including the San Jose Mercury News Woman of Labor, several South Bay Labor Council "Mover & Shaker" awards, and the first "labor seat" on the American Leadership Forum's Class 3; and

WHEREAS,

Nancy Biagini has dedicated her life's work to the labor movement to help ensure that workers have dignity, respect, and a real voice at their workplace; in 1996, she was appointed to International Staff for CWA District 9 and served as a liaison by conducting trainings, arbitrations, bargaining, organizing, and legislative work for various Locals; in 2010, she joined the CWA Headquarters Team and worked in both the Legislative Department and the Human Rights Department; in 2015, she returned to CWA District 9 and worked out of Sacramento until her retirement; and

Nancy Biagini is recognized for all of her work and accomplishments in the past 40 years; she is looking forward to giving back to the community and to starting the next chapter of her life back in her hometown of Santa Clara, California;
