Proposed rate increases for the Solid Waste Program (Garbage, Yard Trimmings, Cleanup Campaign, and Recycling) for Fiscal Year 2026-27 will be considered for adoption at the public hearing.

To formally protest the proposed increases you must do so in writing, as protests cannot be accepted via email, Zoom, or telephone. Written protests must be received before the close of the public hearing. To be counted, protests must be mailed or dropped off to:

If protests are received from a majority of the parcels affected by the proposed rate increase by the close of public hearing, the City Council will not impose the increase.

**NOTICE OF PUBLIC HEARING AND
 PROPOSED SOLID WASTE RATE INCREASES
 FOR UTILITY BILLS
 ON AND AFTER JULY 1, 2026**

The City provides customers with dependable, efficient, safe, and cost-effective solid waste services for residents and businesses that call Santa Clara home.

The proposed solid waste rates were calculated using a rate study which was prepared by an independent, third-party consultant. The study provides a detailed review of the City's solid waste costs to ensure that each rate equitably captures the cost of each service. Each proposed solid waste rate was developed to include the sum of the following cost elements:

- 1) Collection costs
- 2) Processing and disposal or composting costs
- 3) City program costs

Rate increases are necessary to fund the contractually obligated compensation adjustments paid to the City's solid waste service providers.

The City will continue to implement appropriate and prudent cost-saving and cost-controlling measures to maintain the affordability of these basic services.

PROPOSED SOLID WASTE RATES FOR FISCAL YEAR 2026-27

Residential, Commercial and Institutional Customers Only

The proposed rates shown below generate revenues to cover solid waste programs, which include garbage collection, processing and disposal, yard trimmings collection and processing, recyclables collection and processing, the Cleanup Campaign, street sweeping, and other solid waste program overhead and functions. The proposed rates also fund landfill post-closure maintenance and monitoring and financial system software Capital Improvement Projects. These rate increases do not apply to customers in areas zoned for industrial use.
