#### **Solid Waste Rates**

- Services
  - -Garbage
  - -Yard Trimmings
  - -Residential Recycling
  - -Clean-up Campaign (CUC)
- Rates for each service that a customer subscribes to get combined into a bundled rate



# **Compensation Adjustments**

- Effective July 1, 2022
  - -Recology increase @ 13.8% negotiated \*
  - -MTWS increase @ 9.0% negotiated \*
  - -GWR increase @ 4.24%
  - -Republic increase @ 3.1%
- \* Beginning July 1, 2023 annual adjustments based on year over change in the Water, Sewer, Trash Index with a 5% cap and 2% floor

## Front Load Bin Charges

- Loose front load bins increases range from 1.5% 3.7%
  - Dependent on container size/frequency of service
  - Lower increases because of increased subscriptions (+5%)
    - Bin costs spread over a larger base
- Compacted front load bin rates (New Rate)
  - 57% 77% more expensive than loose front load bins
  - -4 current customers

- Most jurisdictions have a separate charge for organics collection service
- Most jurisdictions anticipate rate increases in FY 2022/23

#### **Public Hearing**

- Solid waste customers may submit oral or written protests until the close of the Public Hearing
- At close of Public Hearing, protests are tabulated
  - -34,973 notices were sent on April 7, 2022
  - -If protests tabulated are 50 percent plus one (17,487), the proposed fees cannot be imposed
- If there is not a majority protest, Council can make and act on a motion to increase fees



#### **Recommendation**

1. Adopt a Resolution setting the overall rates to be charged to rate payers for the collection and disposal of garbage, refuse, yard trimmings, recycling, and annual Clean-up Campaign in the exclusive franchise area, effective for the utility bills issued for services rendered on and after July 1, 2022
