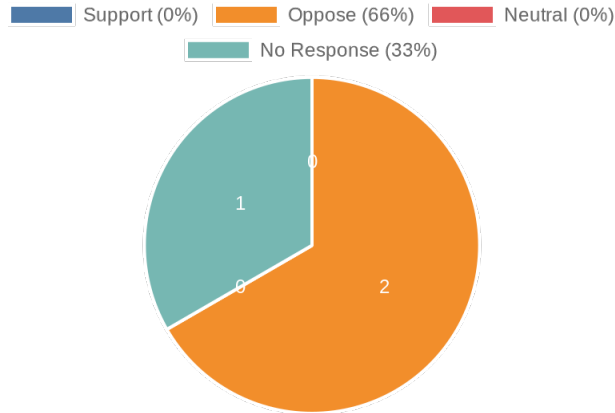

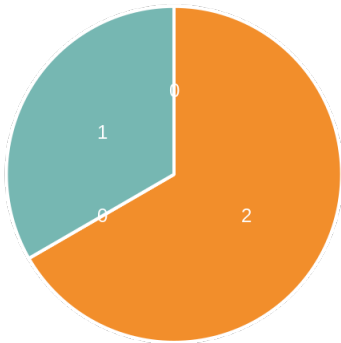

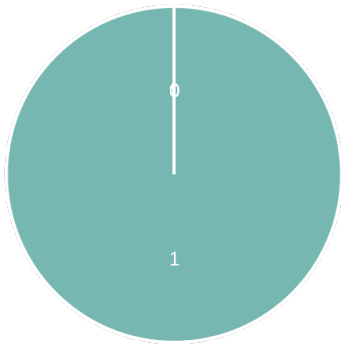
Overall Sentiment

Action needed before global showcase:

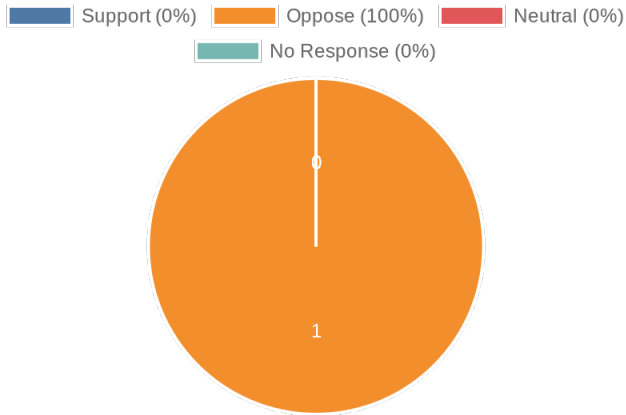
- _ Install No RV Parking/Dumping signs

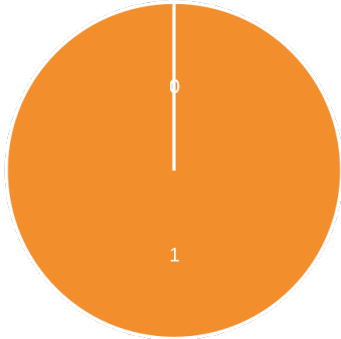

See p. 51 flooring for \$50K tunnel foot traffic, synthetic turf (ST), & for \$160K service corridor "matting." Though cheaper ST wears fast & needs replacing often. ST is not recyclable & will contribute to plastic pollution in landfill or incineration in low-income 'cancer alleys' in other states. If "matting," like ST, is synthetic petroleum-based, it will suffer the same fate as ST. To stop slipping a rough surface is needed, e.g., pervious concrete works, lasts (saving \$) & is recyclable.
