### **PUBLIC PRESENTATIONS**

Commissioner Romano commented on observed construction activity at 712 Jefferson Street. Staff Liaison Jeff Schwilk and Associate Planner Steve Le clarified that an administrative Significant Property Alteration (SPA) Permit had been granted for some work and that the owner is planning to file an application for an expanded work scope that will be referred to the Commission for review as part of a SPA permit in the near future.

## **GENERAL BUSINESS**

2. 22-237 Consideration of Historic Preservation Agreement (Mills Act Contract) and Significant Property Alteration (SPA) Permit to allow a new basement, first floor addition, and new detached Accessory Dwelling Unit (ADU) and garage at 1765 Market Street

**Recommendation:** Staff recommends the Historical and Landmarks Commission find that the house will retain sufficient integrity as a significant example of Queen Anne style architecture through the construction of the proposed addition, subject to the procedures outlined in the Preservation Treatment Plan attached to the Development Plans, and recommend approval of the following:

- 1) That, based upon the analysis and findings of the historical evaluation, the Commission forward a recommendation to the City Council for approval of the Mills Act Contract application, including the adoption of a 10-Year Rehabilitation and Maintenance Plan associated with this historic preservation agreement; and,
- 2) That, based upon the analysis and findings of the historical evaluation, the Commission forward a recommendation of approval for issuance of a Significant Property Alteration (SPA) Permit to the Director of Community Development for the proposed addition, subject to the procedures outlined in the Preservation Treatment Plan attached to the Development Plans.

3. 22-257 Significant Property Alteration (SPA) Permit to replace an existing foundation, convert an existing first floor basement and attic to living area, minor interior alterations, window replacement, and installation of a roof shed dormer at the rear of an existing historic single-family residence located at 1037 Harrison Street.

**Recommendation:** Recommend that the Historical and Landmarks Commission find that the proposed project retains sufficient integrity to qualify as a historic resource and recommend approval of the SPA Permit for the scope of work shown in the Development Plans to the Director of Community Development.

> A motion was made by Commissioner Kirby, seconded by Commissioner Romano to recommend approval of the Significant **Property Alteration Permit to the Director of Community** Development, subject to full restoration of the front windows with all-wood windows constructed of period-appropriate framing, sash and molding dimensions, and including period-appropriate rolled vintage glass, subject to review by a qualified professional and approval by Planning Division staff prior to installation, given the significance of this house as one of five homes in the City of Santa Clara registered in the Library of Congress.

Recommendation: Recommend that the Historical and Landmarks Commission find that the proposed project located at 1854 Market Street will not destroy or have a significant adverse effect on the integrity of the HRI listed property across the street at 1889 Market Street; that the alterations are compatible with the existing structure and its setting in the neighborhood and Old Quad area, and recommend approval to the Development Review Hearing Officer.

The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision. Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. If a person wishes to challenge the nature of the above section in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Santa Clara, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.

If a member of the public submits a speaker card for any agenda items, their name will appear in the Minutes. If no speaker card is submitted, the Minutes will reflect "Public Speaker."
