



Synthetic turf should not be put in any park, even for dogs. Besides high carbon footprint in plastic manufacturing, <https://bit.ly/3na1QPH>, temperatures above synthetic turf are 40-120°F above that of vegetation or even asphalt (<https://bit.ly/3Nmd8LL> - see "surface temperature"). When it's 90°F outside, it can be 130-210°F above plastic grass. Also see this New York Times piece, <https://nyti.ms/39lhoY3> stating "... there are serious environmental problems ... and the costs ... proved so high."


