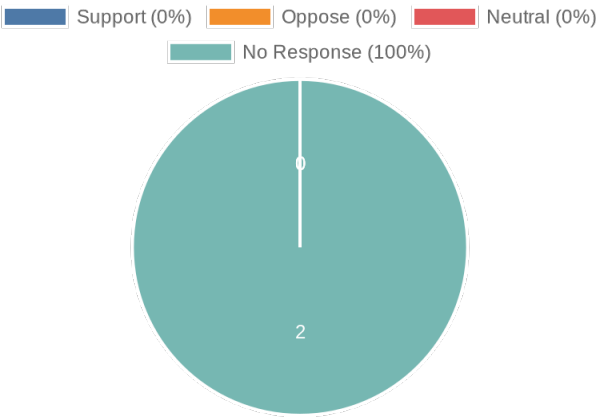

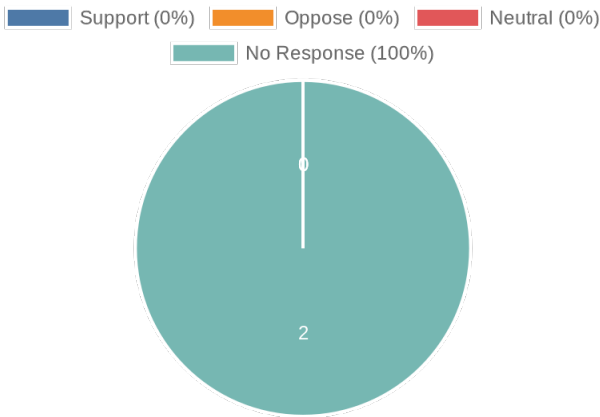

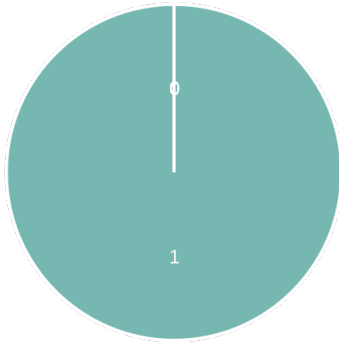
Overall Sentiment

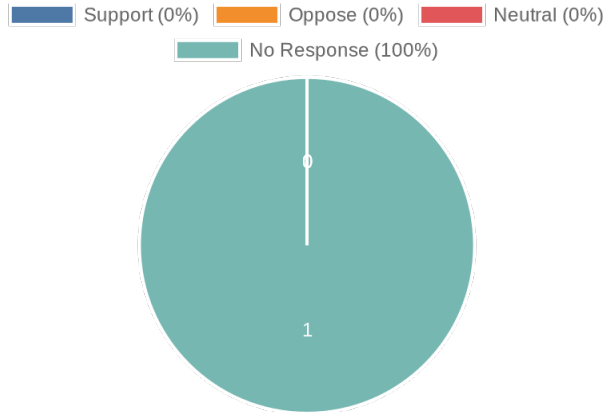

Santa Clara police officers are significantly overpaid. Their starting salaries (~\$155k) and average total compensation (~\$287k) are substantially higher than California's median police salary (~\$113k) and the San Jose metro area median (~\$145k), exceeding compensation in comparable cities. further salary increases would place an unnecessary burden on taxpayers. Given their current high compensation, additional raises could divert essential funds from other critical city services.
