RETIRED ANNUITANT AS A TEMPORARY EXTRA HELP EMPLOYEE (GOVERNMENT CODE SECTIONS 7522.56 AND

21224)

BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

WHEREAS, in compliance with Government Code section 7522.56 the City of Santa Clara must

provide CalPERS this certification resolution when hiring a retiree before 180 days has passed

since his or her retirement date;

WHEREAS, Scott Anderson (CalPERS ID 5494632632) retired from the City of Santa Clara in the

position of Senior Electrical Estimator in the Silicon Valley Department, effective December 23,

2022;

WHEREAS, section 7522.56 requires that post-retirement employment commence no earlier

than 180 days after the retirement date, which is June 20, 2023, without this certification

resolution;

WHEREAS, section 7522.56 provides that this exception to the 180 day wait period shall not

apply if the retiree accepts any retirement-related incentive;

WHEREAS, the City of Santa Clara and Scott Anderson certify that Scott Anderson has not

and will not receive a Golden Handshake or any other retirement-related incentive;

WHEREAS, the City of Santa Clara hereby appoints Scott Anderson as an extra help retired

annuitant to perform the critically needed duties of Temporary Employee for the City of Santa

Clara under Government Code section 21224, effective January 11, 2023;

WHEREAS, the entire employment agreement, contract or appointment document between the

City of Santa Clara and Scott Anderson has been reviewed by this body and is attached herein;

WHEREAS, no matters, issues, terms or conditions related to this employment and appointment

have been or will be placed on a consent calendar;

**WHEREAS**, the employment shall be limited to 960 hours per fiscal year;

**WHEREAS**, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties;

**WHEREAS**, effective December 25, 2022, the maximum hourly salary rate for the Temporary Employee position is \$214.06, and the minimum hourly equivalent is \$17.20;

WHEREAS, the hourly rate paid to Scott Anderson will be \$92.37; and

**WHEREAS**, Scott Anderson has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate.

## NOW THEREFORE, BE IT FURTHER RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

1. The City of Santa Clara hereby certifies the appointment of Scott Anderson and that this appointment is necessary to fill the critically needed position of Temporary Employee for the City of Santa Clara by January 11, 2023. The retired annuitant was the Senior Electrical Estimator for the City of Santa Clara and will be rehired performing the comparable duties of the Senior Electrical Estimator classification. The City would like to rehire Scott Anderson to assist with critical development project backlog, EV Charger electric service design guidelines, essential updates to SVP's Underground Electric Standards (UG1000), and various special projects. Additionally, Mr. Anderson will continue efforts on the Capital Improvement Project to upgrade the Automated Utility Design (AUD) Software and Database to increase accuracy of the cost estimating engine for developer contributions.
