**A RESOLUTION OF THE CITY OF SANTA CLARA, CALIFORNIA  
UPDATING THE RECREATION FIELDS AND TURF  
RESERVATIONS: PRACTICE & GAMES FEES TO BE  
INCORPORATED IN THE FY 2025/26 PROPOSED MUNICIPAL  
FEE SCHEDULE**

**WHEREAS**, under the provisions of the City of Santa Clara Charter, Municipal Code, Constitution of the State of California, and California Government Code, fees and charges assessed by the City of Santa Clara may be amended or modified upon the adoption of a Resolution by the City Council; and,

**WHEREAS**, on April 29, 2025, Council will take action on the FY 2025/26 Municipal Fee Schedule (RTC 25-131);

**WHEREAS**, the FY 2025/26 Proposed Municipal Fee Schedule item describes the Recreation Fields and Turf Areas Reservations: Practice & Games Fees as “unchanged” in order for Council to weigh in on the field and turf user fees; and,

**WHEREAS**, the City has conducted a benchmark analysis and review of its field infrastructure needs; and,

**WHEREAS**, in accordance with the City’s analysis and review, the City now desires to incorporate the updated Recreation Fields and Turf Areas Reservations: Practice & Games Fees into the FY 2025/26 Proposed Municipal Fee Schedule.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:**

1. That the City Council hereby finds that the above Recitals are true and correct and by this reference makes them a part hereof.
2. That the FY 2025/26 Municipal Fee Schedule proposed for Council adoption on April 29, 2025 shall include the updated Recreation Fields and Turf Areas Reservations: Practice & Games Fees as follows:

Resident Youth Non-Profit	\$8/hour
Resident Adult Non-Profit	\$25/hour
Resident	\$60/hour
Non-Resident	\$280/hour
Commercial	\$280/hour

3. The fees described in Section 2 of this Resolution shall supersede the Field and Turf Areas Reservation: Practice and Games fees contained in the FY 2025/26 Proposed Municipal Fee Schedule (RTC 25-131).

4. Effective date. This Resolution shall take effect immediately.
