# Informational Report on FY2019/20 Net Loss on Non-NFL Events



#### Loss on Non-NFL Events

- ManCo projected \$2.7 million Net Loss for FY2019/20 Non-NFL events
- Section 4.7.3 of the Amended and Restated Stadium Lease requires that the Stadium Authority receive all revenue and pay for all expenses related to Non-NFL Events
  - "The Stadium Authority shall be entitled to all Stadium Authority Event Revenue; and...the Stadium Authority shall pay all Stadium Authority Event Expenses."

#### **Summary of Correspondence**

- Stadium Authority received correspondence from ManCo on June 8, 2020 (Attachment 1)
  - Insufficiently detailed, highly summarized, profit and loss statement (Attachment 2) and invoice (Attachment 3)
  - Request to fund \$2.7 million loss with payment certificate to Trust by June 12, 2020 (only four day notice)
  - City of Santa Clara public safety invoices totaling \$1.1 million to be paid AFTER loss is funded



#### **Summary of Correspondence**

- Stadium Authority responded to ManCo on June 10, 2020 (Attachment 4)
  - Four days is not sufficient to review and disburse \$2.7 million
  - Review of accounting records must take place
    - City Auditor reached out to schedule in-person or remote review on June 9, 2020
  - Board must approve budgetary appropriation
  - City of Santa Clara invoices must be paid
    - Measure J does not allow City funds to cover costs of Stadium

#### **Summary of Correspondence**

- ManCo's response letter received June 15, 2020 (Attachment 5)
  - Various claims that Stadium Authority responded to via Informational Report to the Board
  - Review of accounting records can take place once County removes health restrictions
  - City of Santa Clara public safety invoices totaling \$1.1 million paid AFTER loss is funded



#### **Summary of Correspondence**

- Stadium Authority provided final response June 19, 2020 (Attachment 6)
  - SCSA stands by requirement to review accounting records prior to funding net loss of \$2.7 million
  - Stadium Authority Board must approve appropriation after staff has provided sufficient review of records
  - Prompt payment of City of Santa Clara invoices requested
